

BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the November 3, 2020 Consolidated General Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On September 22, 2020, the Board of Supervisors approved the conduct of election services for the Consolidated General Election. The county will pay for federal and state offices that appear on the November ballot while local jurisdictions that have added a measure or special election to the November ballot will reimburse the Registrar of Voters for the full cost of conducting their election.

The election was successfully held on November 3, 2020 with 81% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast for this Consolidated General Election.

Impact on Residents and Businesses

Registered voters who reside in the County of Riverside had the opportunity to elect candidates for federal and state offices and local jurisdiction offices.

Additional Fiscal Information

As approved by the Board of Supervisors on September 22, 2020, local jurisdictions that have added a measure or special election to the November ballot will reimburse the Registrar of Voters for the full cost of conducting their election.
