SUBJECT: RIVERSIDE UNIVERSITY HEALTH SYSTEM - BEHAVIORAL HEALTH: Approve the Purchase Agreement Amendment to the Memorandum of Understanding between California Mental Health Services Authority (CalMHSA), Riverside University Health System-Behavioral Health and the Department of State Hospitals for FY 20/21 and Authorize Payment to CalMHSA, All Districts. [\$9,305,692 Annually for 3 Years, \$27,917,076 Total Cost, State Funds 100%]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the Purchase Agreement Amendment to the Memorandum of Understanding (MOU) between California Mental Health Services Authority (CalMHSA), Riverside University Health System – Behavioral Health (RUHS-BH) and the Department of State Hospitals (DSH) for the purchase of State Hospital Beds for FY20/21 and authorize the Director of RUHS-BH or his designee to sign the Amendment and subsequent renewal amendments on behalf of the County through June 30, 2023; and
2. Authorize payments to CalMHSA in the amount of \$26,638 annually through June 30, 2023.



BACKGROUND:

Summary

The MOU for the Purchase of State Hospital Beds and Participation Agreement outlines CalMHSA and the County’s responsibilities as it applies to mental health services in State Hospital facilities. RUHS-BH currently utilizes approximately forty (40) beds in State Hospitals, including Metropolitan State Hospital, Patton State Hospital and Napa State Hospital. This Program authorized CalMHSA to purchase state hospital beds on behalf of Riverside County and to make payment to the State for such usage consistent with the provisions of the Participation Agreement and the MOU entered into by CalMHSA and DSH.

On December 15, 2015, (3-32), the Board of Supervisors ratified the MOU between CalMHSA, Riverside University Health System - Behavioral Health (RUHS-BH) and the Department of State Hospitals (DSH) for the Procurement of State Hospital Beds for FY 14/15 and FY 15/16. The Board also authorized the Director of RUHS-BH to sign renewals and ministerial amendments to the MOU through June 30, 2018.

On August 29, 2017, (3-90), the Board of Supervisors ratified the Amendment to the MOU for FY 16/17 through FY18/19; authorized the Director of RUHS-BH to sign Amendments to the MOU; and to sign renewals and ministerial amendments to the MOU through June 30, 2019.

On July 2, 2019 (3.20), the Board of Supervisors ratified the Purchase Agreement Amendment for FY19/20 and ratified the CalMHSA Participation Agreement in the amount of \$26,638 for the term July 1, 2017 through June 30, 2020.

Impact on Citizens and Businesses

These services are a component of the Department’s system of care aimed at improving the health and safety of consumers and the community.

Additional Fiscal Information

The approximate annual cost for State Hospital beds is \$9,279,054 and the Participation Agreement with CalMHSA is \$26,638 for a total annual cost of \$9,305,692. There are sufficient appropriations in the Department’s FY20/21 budget. No additional County funds are required.

Contract History and Price Reasonableness

Historically, the RUHS-BH has always contracted directly with the State Hospitals to provide acute, intermediate and skilled nursing psychiatric services to clients of Riverside County. Counties are now under the authority of CalMHSA who jointly negotiates and contracts with DSH for use of such facilities on their behalf. The bed day rates are set by the Department of State Hospitals and range between \$662 to \$775 depending on the level of care.

Purchase Agreement Amendment of State Hospital Beds

Fiscal Year 2020-21

California Department of State Hospitals

By signing this Memorandum of Understanding (MOU) Purchase Agreement Amendment, the Department of State Hospitals (DSH), County, and CalMHSA (collectively "Parties") agree to amend the original FY 2014-15/FY 2015-16 MOU for the purchase of state hospital beds. This Amendment follows extensions of the FY 2014-15/FY 2015-16 MOU in FY 2016/17 through FY 2019, and FY 2019-20.

Once this Amendment is signed by all parties identified in the original FY 2014-15/FY 2015-16 MOU, it shall become effective on July 1, 2020, and shall terminate on June 30, 2021. The Parties agree that the terms and conditions in the FY 2014-15/FY 2015-16 MOU, except for the extension of the MOU for an additional fiscal year, shall remain in effect.

It is acknowledged that DSH is currently developing new bed rates for each Level of Care (LOC) and anticipates notification to CalMHSA and participating counties in the coming months and implementation in accordance with Welfare and Institutions Code sections 4330 - 4335 for a July 2021 effective date.
