**BACKGROUND:**

**Summary**

This First Amendment to the Agreement for Law Enforcement Services with the Southern Coachella Valley Community Services District modifies the level of law enforcement service provided by the Sheriff's Department with the deletion of one (1) Sheriff's Sergeant. On November 9, 2020, the District's General Manager signed the Agreement. County Counsel has approved the Amendment as to form.

Sheriff's staff anticipates this change will result in an estimated decrease of \$191,400 in Contract Law Enforcement Revenue for FY2020-21. The Department is recommending these budget adjustments now as it could not anticipate them to include in its FY20/21 budget request.
