BACKGROUND:

Summary

The Riverside County Flood Control and Water Conservation District (District) owns certain real property located in the city of Temecula, County of Riverside, identified by APN 909-120-040, referenced as RCFC Parcel 7020-102K. EMWD owns APN 909-120-044, which is surrounded on three sides by the District's property with public frontage to Diaz Road. Due to the limited size of their existing lot and necessary repairs to their facilities that require additional property, EMWD has requested to purchase a 120-foot by 80-foot strip of land being approximately 9,600 square feet of land (Property) from the District.

The District has reviewed this proposal and determined that the relinquishment of Property will not impair the design, construction, operation and maintenance of the future Murrieta Creek Channel improvements, therefore, the District recommends that the Property be declared exempt surplus land.

Pursuant to the California Water Code Appendix, Chapters 48-9 and 48-13, the Board of Supervisors of the District has the power to hold, use, acquire, manage, occupy and possess any real property and may determine by resolution duly entered in its minutes that any property, real, personal or mixed, held by the District is no longer necessary to be retained for the uses and purposes thereof and may thereafter sell or otherwise dispose of said Property.

The Property can be declared exempt surplus land pursuant to California Government Code Section 54221(f)(1)(D) because the District is transferring the Property to another local agency for that agency's use as the Property is no longer necessary to be retained in fee by the District for public purposes.

Therefore, District staff is recommending the adoption of Resolution No. F2020-38 to declare the Property exempt surplus land and notice the District's intent to sell its fee simple interest in the Property at or after 9:30 a.m. on January 12, 2021 to Eastern Municipal Water District by Grant Deed.

Resolution F2020-38 has been approved as to form by County Counsel.


