### **BACKGROUND:**

### **Summary**

The Political Reform Act prohibits a public official or employee from using his or her position to influence a government decision in which he or she has a financial interest. Government Code section 87300 requires local government agencies to adopt and promulgate a Conflict of Interest Code identifying officials and employees required to file statements of economic interest based on the positions they hold. A local government agency, as defined by Government Code section 82041, includes the County of Riverside.

The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations section 18730) that contains the terms of a standard conflict of interest code, which may be incorporated by reference in a local government agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. The County of Riverside has incorporated 2 California Code of Regulations section 18730 and any amendments duly adopted by the Fair Political Practices Commission in its conflict of interest code. This regulation and the Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside, designating positions and establishing disclosure categories, constitutes the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside.

Each even-numbered year, Government Code section 87306.5 requires the County of Riverside to review its conflict of interest code and make appropriate revisions, if necessary. Such revisions include adding new positions, revising disclosure categories, revising the titles of existing positions, and deleting titles of positions that have been abolished and/or positions that no longer make or participate in making governmental decisions. Each department, agency, board, commission, committee, and council listed in the Appendix of the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside has reviewed its list of designated positions and disclosure categories. The following departments, agencies, boards, commissions, committees, and councils have found that revisions to its list of designated positions and disclosure categories are necessary:

Attached is the amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside with the above mentioned departments, agencies, boards, commissions, committees, and councils changes to its list of designated positions and disclosure categories.

The Political Reform Act requires the adoption of any amendments to a local government agency's conflict of interest code to be carried out under procedures that guarantee to officers, employees, members, and consultants of the agency and to residents of the jurisdiction adequate notice and a fair opportunity to present their views. Prior to the Board adopting the amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside, the Fair Political Practice Commission recommends a 45-day comment period and a public hearing.

On October 27, 2020, Agenda Item 2.5, the Board of Supervisors set a public hearing on December 15, 2020 regarding the proposed amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside. In addition the Board of Supervisors authorized and directed the Clerk of the Board to place an advertisement for the public hearing in the appropriate local publications and notify each affected designated official or employee.

After the close of the public hearing, it is recommended that the Board of Supervisors adopt Resolution No. 2020-175, A Resolution of the Board of Supervisors of the County of Riverside Adopting an Amended Appendix to the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside.

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE ADOPTING AN AMENDED APPENDIX TO THE CONFLICT OF INTEREST CODE FOR DEPARTMENTS, AGENCIES, BOARDS, COMMISSIONS, COMMITTEES, AND COUNCILS OF THE COUNTY OF RIVERSIDE

WHEREAS, the Political Reform Act, Government Code Section 81000 et seq., requires that state and local government agencies adopt and promulgate conflict of interest codes; and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, 2 California Code of Regulations, section 18730, which contains the terms of a standard conflict of interest code, which may be incorporated by reference in a local government agency's code, and which may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act; and

WHEREAS, the Board of Supervisors of the County of Riverside, State of California, adopted the provisions of 2 California Code of Regulations, section 18730, and any amendments to it as adopted by the Fair Political Practices Commission, with an Appendix in which certain enumerated officials and employees and members of certain enumerated boards, commissions, committees and the Grand Jury are designated and disclosure categories are assigned, to constitute the Conflict of Interest Code for Departments, Agencies, Boards, Commissions, Committees, and Councils of the County of Riverside ("Conflict of Interest Code"); and

WHEREAS, the Board of Supervisors on March 19, 2019, adopted Resolution No. 2019-008 amending the Appendix of the Conflict of Interest Code; and

WHEREAS, changed circumstances within the County have made it advisable and necessary pursuant to Section 87306 and 87307 of the Political Reform Act to amend and update the Appendix of the Conflict of Interest Code; and

WHEREAS, notice of time and place of a public hearing on, and of consideration by the Board of Supervisors of, the proposed amended Appendix was provided to each affected designated official or employee, publicly posted for review at 4080 Lemon Street, Riverside, California, and duly published in a newspaper of general circulation in the County; and

WHEREAS, a public hearing was held regarding the proposed amended Appendix of the Conflict

Consultants, members of boards, commissions, committees and members of the Grand Jury shall file their statements directly with the Clerk of the Board of Supervisors. Statements shall be filed by April 1 of each year to reflect interests held in the prior calendar year.

### **DISCLOSURE CATEGORIES**

The disclosure categories for property and outside business positions, which are established, appear below.

<u>CATEGORY 1</u>: All investments and business positions in, and sources of income (including gifts, loans and travel payments) from, all business entities that do business or own real property in Riverside County, plan to do business or own real property in Riverside County within the next year or have done business or owned real property in the county within the past two (2) years.

Designated Positions assigned to disclose pursuant to Category 1 only are designated for full disclosure and shall disclose pursuant to Categories 1 through 7.

CATEGORY 2: All interests in real property, which is located in whole or part within, or not more than two (2) miles outside, the boundaries of Riverside County.

<u>CATEGORY 3</u>: All investments in, and sources of income (including gifts, loans and travel payments) from, business entities that are engaged in land development, construction or the acquisition or sale of real property in Riverside County, plan to engage in such activities in the County within the next year or have engaged in such activities in the County within the past two (2) years.

<u>CATEGORY 4</u>: All investments and business positions in, and sources of income (including gifts, loans and travel payments) from, business entities that are banking, savings and loan or other financial institutions.

<u>CATEGORY 5</u>: All investments and business positions in, and sources of income (including gifts, loans and travel payments) from, business entities that provide services, supplies, materials, machinery or equipment of a type purchased or leased by the County of Riverside.

<u>CATEGORY 6</u>: All investments and business positions in, and sources of income (including gifts, loans and travel payments) from, business entitles that provide services, supplies, materials, machinery or equipment of a type used or administered or proposed to be acquired by, leased by, used by or administered by the designated employee's department or reviewed, commented upon or recommended by the designated member's Board, Commission, Committee or Council.

CATEGORY 7: All investments and business positions in, and sources of income (including gifts, loans and travel payments) from, business entities subject to review regulation, permitting or licensing authority of the designated employee's department, or designated member's Board, Commission, Committee or Council which will be subject to such authority within the next year or have been subject to such authority within the past two years.
