## BACKGROUND:

## Summary

On May 21, 2019, Item 3.15, the Board of Supervisors (Board) approved in-principle and a project budget in the amount of $\$ 1,104,921$ for the DPSS $3^{\text {rd }}$ Street Shelter Renovation Project. The Third Street Emergency Family Shelter is a County-owned, safe-haven facility administered by Housing, Homelessness Prevention and Workforce Solutions operated by Path of Life Ministries (POLM).

Facilities Management used job ordering contracting to complete the project. The scope of work to the Project included restroom and shower renovations, HVAC system upgrade; new flooring, ceiling and kitchen finishes with plumbing repairs; doors and hardware replacements, fire alarm system, electrical work, ceiling insulation, and field modifications to adjust to existing conditions which occurred during the course of construction.

On December 4, 2018, Item 3.13, the Board approved the construction contract for Job Order Contract (JOC) No. 011 between the County of Riverside (County) and Angeles. Pursuant to the contract, two JOC job orders were issued in the cumulative amount of $\$ 777,358$ which was within the approved construction budget for the Third Street Shelter Renovation Project.

Angeles has completed the work satisfactorily, and the Project has been inspected and found to comply with the contract and safety requirements. This Board action will release the undisputed contract retention funds in the amount of $\$ 38,868$ to Angeles, after the Notice of Completion has been recorded and the 35 -day lien period has expired per contract terms and applicable law.
