**BACKGROUND:**

On December 8, 2020, the Supervisors Spiegel and Perez requested the Executive Office to conduct an After-Action Review of the 2020 General Election process and return with a report and recommendations on the February 9, 2021 Board agenda.

The purpose of the report is to allow the Board of Supervisors, Executive Office, the Registrar of Voters and the community to better understand the election experience. The report's objectives are to identify how to sustain strengths, correct deficiencies and focus on improved performance and results, with concrete and actionable recommendations that will impact future success.

The After-Action Review committee consists of the Executive Office and County Counsel departments. The committee is still in the process of conducting interviews with various parties.
