Two minutes of fame in front of the Riverside County Board of Supervisors February 9, 2021 – 3:30 p.m.

Good afternoon, Supervisors. My name is Charles Russell and I reside in Palm Springs. Thank you for allowing me to speak with you today.

It's no surprise to any of you when I say that residents and health care professionals across this county are disappointed in the COVID vaccine distribution response to those most at risk of hospitalization and death.

During last Tuesday's meeting, Supervisor Spiegel reminded Dr. Leong that "at risk" populations including our seniors and those with compromised immune systems need prioritization. Supervisor Perez told him that farmworkers in the eastern valley also need access to vaccine. And yet, it appears that it's still business as usual without any urgency.

As one of this county's residents at high risk for hospitalization and death, I qualified and received a first dose of vaccine two weeks ago. I have not been able to schedule a second appointment, despite accessing the county's websites more than 20 times each day and persistently telephoning several of the county's community partners.

I elevated this situation to Supervisor Speigel's Chief of Staff last week. During two subsequent phone conversations, she told me that many similar complaints have been referred to this Board and that County Executive Jeff Van Wagenen is now involved in this effort to remedy the shortfall and restore the community's confidence in our county's leadership.

One of our county's largest hospitals even tried unsuccessfully to intervene, making its resources available to provide a second dose to individuals where Community partners, like Albertsons, have abandoned their patients.

Two minutes of fame in front of the Riverside County Board of Supervisors February 9, 2021 – 3:30 p.m.

As our elected officials, you wield influence with county and state services and pass legislation to benefit our community. I am asking that you use these powers and work together so that people like myself don't needlessly die or wind up in our county's hospitals.
