Pete was born May 21, 1926, in Clinton, Oklahoma, on a small farm. His dad, Marion Luther Fletcher, and mom, Zola Fletcher, had 5 girls and LZ (Pete). Although poor, they had what seemed to be, a good life. He had a pony, he went to school, and his five older sisters took good care of him. The family moved to California when Pete was 10 years old. For three years the entire family became itinerant farm workers, living in their vehicles and tents wherever they worked. They picked cotton in Arizona, and Northern California, and Oranges in Southern California.

In 1943 during World War II Pete entered 9th grade. Two weeks later he quit to work full time at American Stamping, near Burbank, California. On his 18th birthday, May 21, 1944, Pete registered for the draft. He received orders from the U.S. Army to report in August to fort Bragg for basic training. After basic training he was shipped out to New Jersey where he would be deployed. He didn't know where was going. Pete spent the first part of his time as an infantry soldier marching from Naples to Venice. Then he was sent to the front lines. Pete was in the Army just short of two years.

When Pete returned home from the service he moved to Burbank, California with his parents. He had friends in Orange, he would see on the weekends. They would cruise near the circle on Glassel street, in front of the theater. On one visit, he saw a beautiful girl working as a cashier, selling tickets to the theater. Pete ran to the ticket booth and asked her out. She agreed and they went to Scotty's malt shop. They were married November 15, 1947 and later had three sons.

Pete owned a successful business, Pete's Road Service. He worked day and night to keep the business going. It was a family business, and everyone in the family worked, Pete made sacrifices and kept the business going through the worst of times. It was his work ethic, and depression mentality, that by example, he instilled in his children, has been the foundation for the success of the company throughout the years.

Clyde joined the U.S. Navy in June of 1942 and served on the U.S.S Sioux until December 1944. The Sioux saw action in five invasions during World War II. Clyde was awarded the American Theater Medal, Asiatic Pacific Theater Medal, the Victory Medals and the Combat Ribbon.

Clyde married Darlene E. Zirzer while on leave, then served in San Francisco and San Diego until his discharge. Clyde joined the Chula Vista Fire Department in 1952 and progressed through the ranks until he was appointed fire chief in 1976. He retired as chief on December 28, 1979 after 27 years with the department. He and his wife then moved to Hemet.

Clyde was always active in the community, serving as a trustee at the Chula Vista Elks Lodge and Hemet Elks Lodge, and a member of the Knight of Columbus. He was also a member of the VFW, the National Association of Fleet Tug Sailors, and the California State Firefighters Association.
