BACKGROUND:

<u>Summary</u>

Riverside County's waste hauler Franchise Collection Agreement for Franchise Area 8 (FA8) and Ordinance No. 769 establish a mechanism for billing residential parcels for waste disposal services. Residential parcels are assessed a fee to cover the costs of operations for three transfer stations run by CR&R, Inc. (Hauler) to accept residential waste and recycling in Anza, Idyllwild, and Pinyon Pines. The roadways in FA8 make it difficult to send individual trash trucks to each residence so, through payment of the annual assessment fee, residential customers have access to dispose of recycling and waste at any of the transfer stations on any day they are operating. The fee covers the disposal of household waste and recycling with no restriction on the number of days a resident may use the sites.

An audit of the billing and assessment process for residential properties in FA8 resulted in identifying approximately 1,550 residential parcels that have never been assessed the fee for residential waste disposal addressed in County Ordinance 769. Ordinance 769 was passed in 1997. The Department of Environmental Health and the Hauler will be mailing out notices to the owners of all the residential parcels that have never been billed to notify them of the intent to include them in future residential billing cycles for FA8. The next billing cycle will be for the 21/22 fiscal year. No attempt will be made to bill these properties for prior unassessed fiscal years.

Impact on Residents and Businesses

The noted residential parcels will be added to the normal residential billing process for FA8. The charge for FY 21/22 is \$196.08. Commercial businesses are not affected by this action.

RESOLUTION NO. 2021-044

A RESOLUTION OF THE COUNTY OF RIVERSIDE TO INCLUDE UNBILLED RESIDENTIAL PARCELS IN FRANCHISE AREA 8 TO THE RESIDENTIAL PARCEL ASSESSMENT BILLING

PROCESS

WHEREAS, California Government Code section 25827 authorizes the Board of Supervisors to prescribe terms and conditions for the collection of solid waste in the unincorporated areas of Riverside County; and

WHEREAS, California Public Resources Code section 40059 authorizes the County of Riverside to determine all aspects of solid waste handling which are of local concern, including whether the services are to be provided by nonexclusive franchise, and the charges and fees for such service; and

WHEREAS, Riverside County Ordinance 769 has established that a solid waste hauler shall be entitled to payment for services rendered in the amounts as specified in a Resolution adopted by the Board of Supervisors; and

WHEREAS, the Board of Supervisors recognizes the benefits of entering into Waste Hauler Franchise Agreements for the efficiency of solid waste management; and

WHEREAS, the County of Riverside has entered into a Waste Hauler Franchise Agreement with CR&R Inc., in Franchise Areas 8 (FA 8); and

WHEREAS, the Department of Environmental Health (Department) has audited the billing process for residential accounts in FA 8 and found a number of residential parcels that have not been assessed for residential waste services as noted in Ordinance 769 since the ordinance adoption in 1997; and

WHEREAS, residential parcels are assessed to cover the cost associated with the operations of three waste and recycling drop offs site operated in Anza, Idyllwild and Pinyon Pines that are available for use by all FA 8 residents; and

WHEREAS, the Department is prepared to mail letters, compliant with Proposition 218, to the owners of all the identified, previously unbilled residential parcels in FA 8 explaining their addition to the annual residential waste parcel billing process, the cost of the annual residential waste assessment for FY 21/22 through

FY 22/23 and that there will be a public hearing to approve the billing additions on April 20, 2021; and 1 WHEREAS, the amount of the annual assessment for residential billing in FA 8 for FY 21/22 is \$196.08 2 and for FY 22/23 is \$216.00: 3 BE IT RESOLVED AND ORDERED that the Board of Supervisors of the County of Riverside, State 4 of California, in regular session assembled on March 2, 2021, finds that the Department shall mail the letters 5 referenced herein to all the unbilled residential parcel owners in FA 8 and hold a public hearing on April 20, 6 2021 to approve the addition of the unbilled parcels to the annual residential waste parcel billing process for FA 7 8 8.

Our records show that your parcel has not previously been assessed the required residential waste fee, going back to the date of Ordinance 769 adoption in 1997. The annual fee for the upcoming fiscal year 2021/2022 is \$196.08. The annual fee will increase to \$216.00 for fiscal year 2022/2023. After June 30, 2023, the annual parcel fee will be adjusted by the annual Consumer Price Index as measured by the Bureau of Labor Statistics. The Riverside County Board of Supervisors will hold a public hearing on April 20, 2021 to discuss the approval of the addition of your parcel to the residential parcel assessment billing process. The County does not intend to capture any fees that were not assessed in previous fiscal years.

The residential waste fee is charged to cover the costs of operating three transfer stations in Anza, Idyllwild and Pinyon Pines that are open for use to all local area residents to deposit recycling and waste materials. The sites also serve to prevent and mitigate illegal dumping throughout the community by offering clean, convenient and safe disposal sites. These stations also help to deter wildfires by offering a safe and efficient pine needle and green waste disposal option for the community.

The annual fee is calculated to offset the operational costs associated with the operations and management of the transfer stations, including but not limited to staffing, equipment, site maintenance, material hauling, processing of the recyclables and waste material.

The fiscal year 2022/2023 rate of \$216.00 is well below the lowest current annual rate for residential trash disposal in neighboring communities. While the neighboring community rates are reflective of curbside service that is not available in your area, those same communities are also limited to fifty-two pick-up days per year with additional costs for increased pick-ups and

overweight or large items beyond the standard service. The three transfer stations for waste dropoff that are available for your area are open up to 5 days a week on a year round basis, with no limit to the number of times that a resident has access to the facilities and no limitations on the size of the items that are allowed to be dropped off.

Proposition 218

Owners and tenants, as defined under Proposition 218, may respond to the proposed fee in writing prior to or during the public hearing. Consistent with the provisions of Proposition 218 and Government Code Section 53755, this notice has been mailed to the recorded owners of the property at the addresses as they appear on the latest equalized assessment roll. If you object to the proposed fees as described in this Notice you may file a written protest with the County at or before the time set for the public hearing. A valid protest must include:
