Zurita Tacos 3-2-2021

Permission for taco vender parking:

I was denied in December 2019 by Jeff Lojeski-RHS

Reason 1, I needed permission from the Transportation department per Ordinance 853. Maria Ortiz confirmed that there is no permit over 74 Hwy in Perris – Lake Elsinore.

Reason 2, I had to park on property after being established with all necessary permits and being no more than 200 feet from a restroom.

Reason 3, property had to be a minimum of ½ acre. I felt discriminated against and searched for other alternatives with another department. The results confirmed that Jeff was correct.

8-2020 Rancho Grill Tacos parks from 4p.m. to 11 p.m. a total of 7 hours daily.

I have made almost daily calls to Environmental Health in Hemet and Indio asking if Rancho Grill Tacos was parked legally and have been told "No".

Finally, Kristin Lorge promised to move it on 1-26-2021 and she did for 15 days. Later, Kristin called me in February to inform me that Rancho Grill Tacos was now legal. I asked her how you can give them permission by going against previous codes or ordinances. I asked to speak to a supervisor in Spanish.

Ralph Fregoso contacted me, and I accused Kristin of corruption. Rafael suggested that I not accuse anyone without proof. If Rancho Grill Tacos was now legal, my surprise was that they were legal. Later I was denied speaking with Ralph Fregoso.

My questions:

Have I been discriminated by Jeff Lojeski and Enrique Rueda's?

Did Kristin Lorge commit corruption?
