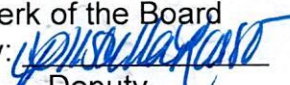

Based on our review, the amounts shown on the "Statement of Assets held by the County Treasurer" as of December 31, 2020, are reasonably stated.

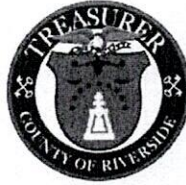
