I am strongly supportive of our Riverside Resolution 2021-041 to Support Assembly Constitution Amendment 3 (ACA 3), which will amend the California Constitution to prohibit slavery and involuntary servitude without exception in our State Constitution. I am a community organizer who supports community members in Coachella, Indio, Riverside and Jurupa Valley.

Currently, the CA Constitution explicitly allows involuntary servitude stating: "There shall be no slavery in this state; nor involuntary servitude, unless for punishment of crimes, shall ever be tolerated in this state". We need to remove this antiquated constitutional language in order to reflect California's current spirit and values of freedom and liberty for all.

Removing involuntary servitude language would not end rehabilitative programming or punishment. It would appropriately state that no one should be slaves under any circumstance. My name is Antoinette Ratcliffe and I am a community advocate and organizer in Riverside County. I am a lifelong resident of Moreno Valley, CA having only relocated briefly to attain my Business Management degree from Cal. State Fullerton, after which I returned to reside in Moreno Valley and work in Riverside for a pre-employment screening company where I assisted formerly incarcerated people in adequately obtaining meaningfully employment upon release, and helped the hiring companies properly vet, screen and hire them.

Currently, the CA Constitution explicitly allows involuntary servitude stating: "There shall be no slavery in this state; nor involuntary servitude, *unless for punishment of crimes*, shall ever be tolerated in this state."; We need to remove this antiquated constitutional language in order to reflect California's current spirit and values of freedom and liberty for all. Removing involuntary servitude language would not end rehabilitative programming or punishment, but instead would allow for more effective rehabilitation.

It is important to take into consideration the various methods used to punish and rehabilitate people who commit crimes including the state of incarceration itself, separation from one's community and family, self-help programs, counseling, vocational training, educational courses, and more. There is no need to use slavery as an additional form of punishment, and it does not positively contribute to one's rehabilitation. Having three brothers currently incarcerated across CA, I also understand the barriers to successful rehabilitation that "jobs" (term used loosely), have on their ability to access programming and education. Due to the conflict between working schedules and programming and/or school schedules, my brothers and countless other individuals in prison are forced away from positive programming and furthering their education by way of forced labor for the state of CA. We here are on the outside wish for our loved ones to truly rehabilitate in hopes of their successful release back home to us. Delaying this process with modern day slavery, is completely unacceptable.

Forced labor is unacceptable and stands in direct opposition to what California claims to be about: liberty, opportunity, strength and empowerment.
