

BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the March 2, 2021 City of Cathedral City Special Municipal Measure Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On January 26, 2021, the Board of Supervisors approved the conduct of election services for the City of Cathedral City Special Municipal Measure Election. Election costs fully reimbursable from the City of Cathedral City are approximately \$91,700.

The election was successfully held on March 2, 2021 with _____% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast for the City of Cathedral City Special Municipal Measure Election.

Impact on Residents and Businesses

Registered voters in the City of Cathedral City had the opportunity to vote on the Cathedral City Short-Term Vacation Rental Regulation Measure that would establish additional regulations on short-term vacation rentals and phase out short-term vacation rentals except where approved by local homeowners associations.

Additional Fiscal Information

As approved by the Board of Supervisors on January 26, 2021, the County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election. Approximately \$91,700 of election costs will be reimbursed by the City of Cathedral City.
