BACKGROUND:

Summary

The County of Riverside, Transportation and Land Management Agency/Aviation received a request from Vernon Poole ("Buyer" or "Assignee") to consent to the assignment of Debra Phillips' interest in that certain Lease (Port-a-Port T-Hangar for Aircraft Storage) dated December 18, 1990 between the County of Riverside, a political subdivision of the State of California ("County") as Lessor, and Debra Phillips, an individual, as Lessee, successor in interest to Kathleen Hamilton, predecessor in interest to Kelly O'Neil, and as amended by that First Amendment to Lease dated September 14, 2004 and by that certain Second Amendment to Lease dated November 24, 2020 (Collectively "Lease").

The Lease pertains to that certain ground space containing approximately 1,092 square feet of land identified as Port-a-Port Space 27 ("Leased Premises") located within the French Valley Airport in Murrieta, California, as more particularly depicted on Exhibit B to the Lease (see attached). Debra Phillips, as assignor, and Vernon Poole, as assignee, entered into the certain Lease Assignment dated January 12, 2021 ("Assignment") relating to the Lease. A copy of the Assignment is attached. Vernon Poole has also acquired from the Debra Phillips an aircraft hangar located on the Leased Premises, the sale of which is memorialized in that certain Bill of Sale dated January 12, 2021 ("Bill of Sale") attached. The Assignment and Bill of Sale require County approval under the Lease. Vernon Poole will not change the existing use of the Leased Premises. The Assignment and Bill of Sale will not impact the terms of the Lease.

Pursuant to the California Environmental Quality Act (CEQA), the Assignment and Bill of Sale were reviewed and determined to be categorically exempt from CEQA under State CEQA Guidelines 15301, Class 1 – Existing Facilities and State CEQA Guidelines 15061(b) (3), General Rule or "Common Sense" exemption. The proposed project, the assignment of lease rights under an existing Lease and sale of the existing hangar, is the leasing of property involving existing facilities and no expansion of an existing use will occur. In addition, it can be seen with certainty that there is no possibility that the proposed project may have a significant effect on the environment since it is merely a continuation of existing use. Staff will file a notice of exemption with the Clerk of the Board upon approval of the consent to Assignment and consent to the Bill of Sale.

Staff recommends approval of the attached Consent to Assignment, and Consent to Bill of Sale. The attached Consent to Assignment and Consent to Bill of Sale have each been approved as to form by County Counsel.

Impact on Citizens and Businesses

The Lease and Bill of Sale will assist in the County's effort to increase airport operations which in turn provides increased patron activities for local businesses.



Neeley, Bart Phillips, Verne Poole and Kristine Poole, Phil Roy, Kenneth Rauton, Richard Weiner, Donald Chapton, Dee Johnson, Mike Leckliter, Kimball Mckinney, James Scott, Debra Phillips, and John P. Wirt.

This second amendment to the lease extends the term of the lease from January 1, 2021 to December 31, 2030. Second Amendment to Lease French Valley Airport Port A Port

This SECOND AMENDMENT TO LEASE ("Second Amendment") is made and entered into on this 24 day of November, 2020, by and between the County of Riverside, on behalf of its Transportation and Land Management Agency, Aviation Division, a political subdivision of the state of California, ("County") and Debra Phillips, a [successor of interest to Kelly O. Neil.] ("Lessee"), with reference to the following:

RECITALS

WHEREAS, County and Lessee entered into that certain Lease (Port-A-Port T-Hangar for Aircraft Storage) at French Valley Airport, dated December 19, 1990, ("Lease"), whereby, among other things, Lessee agreed to lease from County approximately 1,092 square feet of land located at the French Valley Airport known as Space # 27 ("Leased Premises").

WHEREAS, the Lease was amended by that certain First Amendment to Lease dated September 14, 2004, by and between County and Lessee; and

WHEREAS, Lessee now desires, pursuant to Section 3 of the Lease, to exercise its option to extend the term of the Lease for an additional period of ten (10) years on the same terms and conditions; and

WHEREAS, The Original Lease together with the First Amendment and this Second Amendment are collectively referred to herein as the "Lease;"

WHEREAS, County and Lessee now desire to amend the Lease to extend the Lease term for an additional ten (10) years.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree that the Lease shall be modified as follows:

Term Section 3 (Term) of the Lease is hereby amended by the following:
 The term of the Lease shall be extended for ten (10) years, commencing
 on January 1, 2021 ("Effective Date") and expiring on December 31, 2030. Any holding

over by the Lessee after the expiration of the Lease shall be on a day-to-day basis strictly, and continuing tenancy rights shall not accrue to the Lessee.

2. Miscellaneous

- a. <u>Construction of Second Amendment</u>. The parties hereto negotiated this Second Amendment at arm's length and with advice of their respective attorneys, and no provisions contained herein shall be construed against Lessor solely because it prepared this Second Amendment in its executed form.
- b. <u>Capitalized Terms/Second Amendment to Prevail</u>. Unless defined herein or the context requires otherwise, all capitalized terms herein shall have the meaning defined in the Lease, as heretofore amended. The provisions of this Second Amendment shall prevail over any inconsistency or conflicting provisions of the Lease, as heretofore amended, and shall supplement the remaining provisions thereof.
- c. <u>Further Cooperation</u>. The parties agree to execute such other instruments, agreements and amendments to documents as may be necessary or appropriate to effectuate the Lease as amended by this Second Amendment.
- d. <u>Interpretation</u>. This Second Amendment, when combined with the Lease and all amendments hereto, sets forth and contains the entire understanding and agreement of the parties hereto and correctly sets forth the rights, duties and obligations of each to the other as of this date.
- e. <u>Waivers: Amendments</u>. All waivers of the provisions of this Second Amendment and all amendments hereto must be in writing and signed by the appropriate authorities of County and Lessee.
- f. <u>Attachments</u>. Each of the attachments and exhibits attached hereto are incorporated herein by this reference.
- g. <u>Effectiveness of Lease</u>. Except as modified and amended by this Second Amendment all other terms and conditions of the Lease remain unmodified and in full force and effect. If any provisions of this Second Amendment or the Lease shall be determined to be illegal or unenforceable, such determination shall not affect any

other provision of the Lease and all such other provisions shall remain in full force and effect. The language in all parts of the Lease shall be construed according to its normal and usual meaning and not strictly for or against either County or Lessee. Neither this Second Amendment, nor the Lease, nor any notice nor memorandum regarding the terms hereof, shall be recorded by Lessee.

- h. <u>Counterparts</u>. This Second Amendment may be signed by the different parties hereto in counterparts, each of which shall be an original but all of which together shall constitute one and the same agreement.
- i. <u>Effective Date</u>. The effective date of this Second Amendment is the date provided above in Section 1 of this Second Amendment.

Summary

Pursuant to Paragraph 21 of that certain Lease (Port-a-Port T-Hangar for Aircraft Storage) executed by the County of Riverside ("County"), (as lessor), and Kelly O'Neil, an individual, predecessor in interest to Kathleen Hamilton, (as lessee), dated December 18, 1990, as amended by that certain First Amendment to Lease French Valley Airport dated September 14, 2004 (collectively, the "Lease"), Kathleen Hamilton has requested that the County ratify and consent to the assignment of her rights, title, interest and obligations under the Lease to Debra Phillips. A copy of the Lease is attached hereto. The Lease pertains to that certain real property located within French Valley Airport located in Murrieta, California and consists of approximately 1,092 square feet of land identified as Space No. 27 ("Leased Premises").

Kathleen Hamilton (Assignor therein) and Debra Phillips (Assignee therein) executed that certain Assignment dated November 4, 2013 (Assignment), the effectiveness of which is subject to the prior consent and approval by the County. A copy of the Assignment is attached. Debra Phillips has also acquired from Kathleen Hamilton a Port-a-Port aircraft storage hangar located on the Leased Premises, the sale of which is memorialized by a Bill of Sale attached hereto. Debra Phillips will not change the existing use of the Leased Premises.

Economic Development Agency staff recommends that the Board of Supervisors ratify and consent to the Assignment and approve the execution of the attached Ratification and Consent to Assignment of Lease (Porta-Port T-Hangar for Aircraft Storage). County and Kathleen Hamilton (successor in interest to Kelly O'Neil), herein called Lessee, hereby agree to amend the Lease between the parties as follows:

1. Page 1, paragraph 2 add the following after the last sentence:

No other use will be permitted without first obtaining written permission from County. The aircraft to be stored in the Premises is described as follows:

Should the aircraft stored in the hangar be replaced with another aircraft owned by Lessee or with a Sublessee's aircraft, Lessee agrees to notify County within ten (10) days and supply County with the Make, Model and Identification number of the replacement aircraft. In addition, Lessee shall provide, or shall cause Sublessee to provide, all required Certificates of Insurance, endorsements and any other documentation required herein with respect to the replacement aircraft being stored in the hangar.

- 2. Page 1, paragraph 3. <u>Term</u>, subparagraph (a) line 14, the termination date shall be changed to December 31, 2020.
- 3. Page 1, paragraph 3. <u>Term</u>, after subparagraph (b) add the following subparagraph (c):
 - (c) Lessee shall have the option to extend the term of this Lease for an additional period of ten (10) years on the same terms and conditions, except that the basic monthly rent on July 1, 2030 shall be adjusted in the same manner as

- 5. Page 1, paragraph 4. <u>Basic Rent</u>, subparagraph (b) shall be deleted and the following subparagraph (b) substituted:
 - (b) The basic monthly rent is due and payable on or before the first day of the appropriate month during the term of this Lease agreement and shall be considered delinquent, if not paid by the 15th of the month. If the monthly rent becomes delinquent, Lessee will be charged a late fee equivalent to ten percent (10%) of the delinquent rental amount, exclusive of late fees, for each month that rent is delinquent.
- 6. Page 1, paragraph 5. <u>Basic Rental Adjustment</u> shall be deleted in its entirety and in its place the following shall be inserted:

5. Basic Rental Adjustment

(a) Beginning July 1, 2004 and on every July 1st thereafter during the term of this Lease and any extension thereof, except for the year 2010 as provided for in 5 (b) below, the basic monthly rent specified in paragraph 4 shall be increased by the same percentage as the increase in the Consumer

A property appraisal for this purpose is to be performed by an independent certified appraiser, procured by County, knowledgeable in aviation appraising and in good standing with the American Institute of Real Estate Appraisers. Once established, said rent shall be adjusted annually in the manner set forth in Paragraph 5(a) above. Nothing herein shall be deemed to provide for any reduction in, or for an increase greater than 25%, of the basic monthly rent of the previous year.
- 7. Page 2, paragraph 6 Improvements. Add subparagraph (c) as follows:
 - (c) Relocating the Hangar: Lessee shall advise County in writing prior to any relocation of the hangar. Lessee agrees that no relocation shall occur unless the County agrees, in writing, to the method, scheduling and route of hangar movement prior to move. Such Agreement by the County to Lessee relocating the hangar will not be unreasonable withheld. If Lessee is to use an outside relocation service, such service must meet the County's insurance requirements and provide evidence of their insurance prior to coming onto the airport premises.
- Page 3, paragraph 8 <u>Ingress and Egress</u>. Add the following sentence:

Policy's limit of liability shall not be less than \$1,000,000 per occurrence and in the aggregate if applicable.

If Lessee subleases one or more hangars, Lessee shall either:

(d) Aircraft Liability Insurance. Lessee shall provide Aircraft Liability insurance for all owned and non-owned aircraft operated by the Lessee

The COUNTY OF RIVERSIDE, herein called County, leases Kelly O'Neil _, herein called Lessee, the property described below upon the following terms and conditions:

- 1. Description. The premises leased hereby are located within French Valley Airport, Mursdeta, California and consist of approximately 1,092 square feet of land identified as Space No. 27, as more particularly shown on Exhibit "A", attached hereto and by this reference made a part of this lease.
- The premises are leased hereby for the purpose <u>Use</u>. of installing and maintaining a Port-a-Port T-Hangar therein for aircraft storage and aircraft supporting equipment in connection

- commencing December 1 , 19 90, and terminating December 31 2010, subject to the provisions contained in Paragraphs 14 and 15 herein.
- (b) Any holding over by Lessee after the expiration of this lease shall be on a day-to-day basis strictly, and continuing tenancy rights shall not accrue to Lessee.





Description of Project: The County of Riverside, Transportation and Land Management Agency/Aviation received a request from Vernon Poole to consent to the assignment of Debra Phillips' interest in that certain Lease (Port-a-Port T-Hangar for Aircraft Storage) dated December 18, 1990 between the County of Riverside, a political subdivision of the State of California (County) as Lessor, and Debra Phillips, an individual, as Lessee, successor in interest to Kathleen Hamilton, predecessor in interest to Kelly O'Neil, and as amended by that First Amendment to Lease dated September 14, 2004 and by that certain Second Amendment to Lease dated November 24, 2020 (Collectively Lease).

The Lease pertains to that certain ground space containing approximately 1092 square feet of land identified as Port-a-Port Space 27 (Leased Premises) located within the French Valley Airport in Murrieta, California, as more particularly depicted on Exhibit B to the Lease. Debra Phillips, as assignor, and Vernon Poole, as assignee, entered into the certain Lease Assignment dated January 12, 2021 (Assignment) relating to the Lease. Vernon Poole has also acquired from the Debra Phillips an aircraft hangar located on the Leased Premises, the sale of which is memorialized in that certain Bill of Sale dated January 12, 2021 (Bill of Sale). The Assignment and Bill of Sale require County approval under the Lease. Vernon Poole will not change the existing use of the Leased Premises. The Assignment and Bill of Sale will not impact the terms of the Lease. The consent to Assignment and Bill of Sale is identified as the proposed project under the California Environmental Quality Act (CEQA). The consent to the Assignment and Bill of Sale is limited to a contractual obligation and will not result in any direct effects on the environment. The indirect effects of the consent of the agreements would result in the change of contractual responsibilities of the Port-a-Port Space 27 T-Hangar at French Valley Airport, which will also not result in any significant impacts.

Name of Public Agency Approving Project: Riverside County

Name of Person or Agency Carrying Out Project: Riverside County Facilities Management

Exempt Status: State CEQA Guidelines Section 15301, Class 1, Existing Facilities Exemption; Section 15061(b) (3), General Rule or "Common Sense" Exemption. Codified under California Code of Regulations Title 14, Article 5, Section 15061.

Reasons Why Project is Exempt: The proposed project will not result in any specific or general exceptions to the use of the categorical exemption as detailed under State CEQA Guidelines Section 15300.2. The project will not cause an impact to an environmental resource of hazardous or critical concern nor does the project involve any unusual circumstances that could potentially have a significant effect on the environment. The project would not result in impacts to scenic highways, hazardous waste sites, historic resources, or other sensitive natural environments, or have a cumulative effect to the environment. The consent to the agreements would have no direct effects on the environment and the indirect effects would result in continuing use of the site in a similar capacity. No significant environmental impacts would occur with the consent to the Assignment and Bill of Sale.

- Section 15301 Existing Facilities: This Class 1 categorical exemption includes the operation, repair, maintenance, leasing, or minor alteration of existing public or private structures or facilities, provided the exemption only involves negligible or no expansion of the previous site's use. The project, as proposed, is limited to the consent to a Membership Interest Redemption Agreement and the Assignment of the Sublease regarding Hangar 1A within the French Valley Airport. The changes are limited to the change in ownership and responsibility for the terms of the Lease. The consent to Assignment and Bill of Sale will result in the same purpose and substantially similar capacity on the existing facilities at the airport and would be consistent with the existing land use and contractual requirements for the use of the site. Therefore, the project is exempt as it meets the scope and intent of the Categorical Exemption identified in Section 15301, Article 19, Categorical Exemptions of the CEQA Guidelines.
- Section 15061 (b) (3) "Common Sense" Exemption: In accordance with CEQA, the use of the Common Sense Exemption is based on the "general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment." State CEQA Guidelines, Section 15061(b) (3). The use of this exemption is appropriate if "it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment." Ibid. This determination is an issue of fact and if sufficient evidence exists in the record that the activity cannot have a significant effect on the environment, then the exemption applies and no further evaluation under CEQA is required. See No Oil, Inc. v. City of Los Angeles (1974) 13 Cal. 3d 68. The ruling in this case stated that if a project falls within a category exempt by administrative regulation or 'it can be seen with certainty that the activity in question will not have a significant effect on the environment', no further agency evaluation is required. With certainty, there is no possibility that the project may have a significant effect on the environment. The consent to Assignment and Bill of Sale and is an administrative function, that is required as part of the terms of the Lease at the existing airport and would result in the continued operation of the airport on the leased premises under modified contractual responsibilities. No significant direct or indirect environmental impacts would occur. Therefore, in no way, would the project as proposed have the potential to cause a significant environmental impact and the project is exempt from further CEQA analysis.

Based upon the identified exemptions above, the County of Riverside, Facilities Management hereby concludes that no physical environmental impacts are anticipated to occur and the project as proposed is exempt under CEQA. No further environmental analysis is warranted.
