BACKGROUND:

Summary

The Riverside County Flood Control and Water Conservation District (District) acquired the subject real property by Grant Deed recorded December 23, 1949 in Book 2504, Page 317 of Official Records for the Highgrove Storm Channel project, which consisted of the construction and subsequent operation and maintenance of a canal. The District owns RCFC Parcel No. 1030-5B (Property) in fee.

The District received an unsolicited inquiry from an adjacent property owner (potential buyer) that is looking to incorporate said parcel with their existing property. Subsequently, the District was able to determine that the Property is no longer needed for the District's uses or purposes. By selling the Property, it would remove both the obligation of maintenance and responsibility by the District and would place the Property back on the property tax roll.

Pursuant to California Water Code Appendix, Chapter 48-9, Subsection 5 and Chapter 48-13, the Board of Supervisors of the District (Board) is authorized to dispose of real property that is no longer necessary to be retained for the uses and purposes of the District. The Property is no longer necessary to be retained for the Highgrove Storm Channel or any District uses or purposes, therefore, staff recommends the adoption of Resolution No. F2021-11 to declare the Property surplus and to dispose of it. Upon the Board declaring the Property as surplus and before it is sold, the District will seek an appraisal to value the Property.

Pursuant to California Government Code Section 54221(f)(1)(E), surplus land that is a former street, right of way or easement and is conveyed to an owner of an adjacent property is exempt surplus land and thus the Surplus Land Act does not apply to this transaction. Therefore, the District can proceed to negotiate a purchase price with the potential buyer. After negotiations have concluded, District staff will present an agreement for the disposition of the Property to the Board for approval.

Resolution No. F2021-11 has been approved as to form by County Counsel.


