BACKGROUND:

Summary

The Assessor-County Clerk-Recorder (ACR), in accordance with Riverside County Board Policy B-4 (Rates Charged for Current Services), has determined that updates to the ACR's fees are necessary to comply with changing legislation.

The amendment to Ordinance 729 will update the statutory pass-through fees pertaining to the California Environmental Quality Act and Environmental Document Filing fees. These fees are adjusted annually by the California Department of Fish and Wildlife in accordance with Fish and Game Code Sections 711.4 and 713 and are uniform throughout the State of California.

In addition, the Real Estate Fraud Prosecution Trust Fund fee is set to \$10.00, in compliance with County Resolution No. 2013-038 and as permitted by Section 27388 of the Government Code.

Due to these fees being pass-through, no budget adjustment is necessary.
