BACKGROUND:

Summary

On December 10, 2019, the Board of Supervisors approved a Consulting Services Agreement ("Agreement") between the District and the Consultants (Board Agenda Item No. 11.1). Pursuant to this Agreement, the Consultants were retained to provide on-call services.

This no-cost Amendment will extend the term of the Agreement by one year (Fiscal Year 2022/2023). The previously approved not-to-exceed compensation amount and contract pricing will remain the same. The extension of the term of the Agreement by one year provides a reasonable additional timeframe for the Consultants to complete the assigned tasks that may be issued close to June 30, 2022.

County Counsel has approved the Amendment as to legal form.

Contract History and Price Reasonableness

On December 10, 2019 (Agenda Item No. 1111), the Board of Supervisors approved the District's On-Call Aerial Imagery and/or Light Detection and Ranging Services Consulting Services Agreement. The District published a Request for Qualifications – FCARC-00153 Aerial Imaging and Light Detection and Ranging (LiDAR) Services on March 29, 2019; it closed on April 19, 2019. Three firms responded, and a selection committee comprised of District employees reviewed each firm's qualifications. Digital Mapping Incorporated and Quantum Spatial, Inc. were selected based on relevant experience, technical competence, past performance and their proposed work plan.

FIRST AMENDMENT TO
CONSULTING SERVICES AGREEMENT WITH
QUANTUM SPATIAL, INC.

This First Amendment to Consulting Services Agreement ("FIRST AMENDMENT"), dated as of March 30, 2021, is entered into by and between the Riverside County Flood Control and Water Conservation District, a body politic ("DISTRICT"), and Quantum Spatial, Inc., a Wisconsin corporation ("CONSULTANT"), sometimes collectively referred to as the "Parties".

RECITALS

A. DISTRICT and CONSULTANT previously entered into that certain Consulting Services Agreement ("ORIGINAL AGREEMENT") for Fiscal Years July 1, 2019 through June 30, 2022 for CONSULTANT to provide on-call professional services.

B. ORIGINAL AGREEMENT entered into as of December 10, 2019, together with this FIRST AMENDMENT are collectively referred to herein as "Agreement".

C. The Parties now desire to amend ORIGINAL AGREEMENT to extend the term period set forth in Section 4.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree as follows:

1. TERM Section 4 of the Agreement is hereby amended as follows:

"The term of this Agreement shall become effective on the date it is executed and shall remain in effect through the required date for completion of an assigned Task Order, provided that such Task Order was approved prior to June 30, 2022 and is to be completed by June 30, 2023."

2. CAPITALIZED TERMS FIRST AMENDMENT to prevail. Unless defined herein or the context requires otherwise, all capitalized terms herein shall have the meaning defined in the Agreement, as heretofore amended. The provisions of this FIRST

AMENDMENT shall prevail over any inconsistency or conflicting provisions of the Agreement as heretofore amended and shall supplement the remaining provisions thereof.

3. MISCELLANEOUS Except as amended or modified herein, all the terms of the Agreement shall remain in full force and effect and shall apply with the same force and effect. Subject to the provisions of the Agreement as to assignment, the agreements, conditions and provisions herein contained shall apply to and bind the heirs, executors, administrators, successors and assigns of the parties hereto. If any provisions of this FIRST AMENDMENT or the Agreement shall be determined to be illegal or unenforceable, such determination shall not affect any other provision of the Agreement, and all such other provisions shall remain in full force and effect. The language in all parts of the Agreement shall be construed according to its normal and usual meaning and not strictly for or against either DISTRICT or CONSULTANT.

4. EFFECTIVE DATE This FIRST AMENDMENT to ORIGINAL AGREEMENT shall not be binding or consummated until it is fully executed by the Parties.

5. This FIRST AMENDMENT may be executed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument.
