On motion of Supervisor Spiegel, seconded by Supervisor Perez, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, April 20, 2021, be adjourned in memory of Ronald Taber, who passed away on March 7, 2021, at the age of 83.

Ronald was born in St. Johns, Michigan on July 21, 1937 to Lloyd and Edna (Gordon) Taber. Ronald was the sixth of eight sons. His first eight years were filled with many adventures on the family farm. The family decided to relocate, and settled in Riverside, California.

Ronald started his first job as a paperboy as soon as age allowed, followed by enlistment in the U.S. Navy during the Korean War. He married Mary Ann Williamson on February 16, 1956 and together they raised four sons. After returning from the Navy, Ronald joined his brothers in Riverside, becoming a union plumber working for his eldest brother Clare's shop, Taber Plumbing Company.

Ronald purchased a house on an acre of land in Jurupa Valley, with zoning for animals, in 1968. With this and another 17 acres nearby, he recreated the farming experiences he was raised with, for his sons. When Taber Plumbing discontinued residential plumbing, Ronald and his sons opened R. Taber and Sons Plumbing, which ran successfully for over 25 years. Ronald's children were his greatest love. He supported them as a scout leader, and by enabling their memberships in 4-H and FFA.

Ronald had a passion for fishing, which inspired many family outings, memorable moments, and great tales. After retiring, Ronald continued the activities he loved best, family time, traveling, fishing and visiting casinos. He spent his last years living with, his youngest son Timothy and daughter-in-law Lisa Hope, where he was lovingly cared for.

Ronald's memory and passionate spirit will live forever in the hearts of those who knew and loved him, he will be greatly missed but never forgotten.

On motion of Supervisor Spiegel, seconded by Supervisor Perez, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, April 20, 2021, be adjourned in memory of Pat Rizzo, a Palm Springs resident and saxophonist, who passed away on April 15, 2021 at the age of 79, after a five-year battle with cancer.

Pat Rizzo was born in New York November 30, 1941. He grew up in the Astoria neighborhood in Queens. Pat attended the Manhattan School of Music, where he studied classical flute, clarinet, and saxophones. He also learned the piano as a kid while listening to his mother, Marry Rizzo, a concert pianist from Gioia Del Colle, Italy.

Pat moved to Palm Springs in 1972. He played with War, Tito Puente and Frank Sinatra. He was a member of Sly and the Family Stone, from 1970-1975. Rizzo bought a home in Rancho Mirage. He took his money from Sly and the Family Stone, and co-founded Palm Springs' first disco, Pal Joey's supper club. Pat used his knowledge of what was popular in disco to program Pal Joey's music.

Pat Rizzo received a star on the Palm Springs Walk of Stars in 2016. Pat considered Palm Springs his sanctuary. He was a legend in Palm Springs and had affiliations with many charities and foundations. He was a music legacy and had an impact on so many musicians and fans. In recent years, Rizzo played shows in Palm Springs at the Purple Room Supper Club, the Three Sixty North Lounge and Restaurant and Vicky's of Santa Fe, in Indian Wells. He was exceptional, he could play jazz and rock n roll.
