BACKGROUND:

Summary

The Emergency Food and Shelter Program (EFSP) was created by Congress to help meet the needs of hungry and homeless people throughout the United States and its territories by allocating federal funds for the provision of food and shelter. The Program is administered by the Department of Homeland Security's (DHS) Federal Emergency Management Agency (FEMA) and this agency allocates funds to the EFSP National Board.

The EFSP National Board was appropriated supplemental funds under the Coronavirus Aid, Relief and Economic Security (CARES) Act in FY 2020 in the amount of \$200 million. The Local EFSP Board, consisting of representatives from government and nonprofit agencies, is responsible for allocating EFSP funds to service providers and for selecting recipients that will provide emergency food and shelter services based on the needs and changes in Riverside County. On February 8, 2021, DPSS competed and was awarded \$196,389 to expand assistance to homeless seniors throughout Riverside County who are referred to the DPSS Adult Protective Services program. DPSS will utilize the funds allocated by the Local Board to support APS clients with food vouchers, food pantries, hotel/motel vouchers, and rent/mortgage assistance.

DPSS desires to apply and accept EFSP funds annually to ensure continued emergency services for our homeless seniors, among the most vulnerable populations of Riverside County. Approval from the Board of Supervisors to allow the DPSS Director, or Designee, to apply and accept these funds annually will eliminate delays in providing needed food and shelter programs to our clients. The department anticipates the continuation of the EFSP, and funding will be accounted for in the budget for upcoming fiscal years.

According to the terms of the grant from the national board, local governmental or private voluntary organizations chosen to receive funds must: (1) be private voluntary non-profits or units of government, (2) have an accounting system, (3) practice non-discrimination, (4) have demonstrated the capability to deliver emergency food and/or shelter programs, and (5) if they are a private voluntary organization, they must have a voluntary board.

Additional Fiscal Information

A jurisdiction may use up to 2% of its award for administrative purposes. State Set-Aside Committees may use up 0.5% for administrative purposes. The National Board uses up to one percent of the total allocation for its administrative costs.

Impact on Residents and Businesses

When a jurisdiction is funded, the Local Board must advertise the availability of funds. Local organizations, whether nonprofit or governmental, may apply. The Local Board is responsible for considering all applications, and for determining which organizations will receive funds. The Local Board also determines which services are funded.
