BACKGROUND:

Summary

On August 27, 2019, the Board of Supervisors approved the Five-Year Law Enforcement Services Agreement with the Riverside County Superintendent of Schools for the provision of one (1) Deputy Sheriff School Resource Officer at the Betty G. Gibbel Regional Learning Center in San Jacinto. The Riverside County Superintendent of Schools notified the Riverside County Sheriff's Department on February 24, 2021 of their desire to terminate the Law Enforcement Services Agreement at the end of year two, pursuant to Section 9 of the Agreement. This mutual termination is effective June 30, 2021.

The Department has included no cost estimate in its budget; therefore, no budget adjustment is necessary. County Counsel has reviewed the mutual termination request and approved the Mutual Termination as to form.
