

- 3. Authorize the release of the undisputed retained funds in the amount of \$8,960 to Horizons in accordance with the contract terms and applicable law, per the General Conditions of the contract.

BACKGROUND:

Summary

On June 16, 2020, Item 3.16, the Board of Supervisors (Board) approved in-principle and a project budget in the amount of \$228,066 for the Office of Economic Development Riverside Centre 4th Floor Project, formerly known as the Riverside County Business and Community Services Riverside Centre 4th Floor Reconfiguration Project; for the reconfiguration of the 4th floor office space at 3403 10th Street to accommodate staff relocation from other office locations, as well as provide for a safe and healthy environment.

Facilities Management used job ordering contracting to complete the project. The scope of work included paint and recarpeting of various areas on the 4th Floor.

On January 14, 2020, Item 3.7, the Board approved the construction contract for Job Order Contract (JOC) No. 012 between the County of Riverside (County) and Horizons. Pursuant to the contact, one job order was issued in the amount of \$179,204 for the Office of Economic Development Riverside Centre 4th Floor Project.

Horizons has completed the work satisfactorily, and the Project has been inspected and found to comply with the contract and safety requirements. This Board action will release the undisputed contract retention funds in the amount of \$8,960 to Horizons, after the Notice of Completion has been recorded and the 35-day lien period has expired from the start of the recorded date, per contract terms and applicable law.

Impact on Residents and Businesses

The Office of Economic Development provides pivotal service in support of local businesses and residents throughout the local health crisis and beyond. The improvements will ensure a safe and healthy work environment.
