

#### BACKGROUND:

#### Summary

The Riverside County Fairgrounds are approximately 120 acres in size and have been the home of the Riverside County Fair & National Date Festival since 1945. The Fair & National Date Festival events are not only major tourist attractions and integral to the community, but the grounds themselves have continued to serve an important role in allowing for provision of vital services to county residents. During the past year, the site has been essential to the County's COVID-19 response. Since April 2020, the fairgrounds have been requisitioned for use as both a COVID-19 testing site and Federal Medical Station (FMS), and since January of this year, the site has operated as a COVID-19 vaccination site.

The COVID-19 pandemic resulted in cancellation of all live events and large gatherings around the world, including on the fairgrounds. Subsequently, since March 2020, the Fairgrounds Budget has steadily lost revenue from lack of seasonal rentals. Although the current fiscal year budget was reduced by half, maintaining a minimum level of staff for coordination of the testing site, FMS, and the vaccination clinic has been critical. CARES Act funding in the amount of \$2,579,860 was approved for establishment of COVID-response related temporary medical facilities and facility improvements on site; however, other needed maintenance projects have had to be delayed due to lack of funding.

The Office of Economic Development has historically addressed maintenance of the fairgrounds site and administration of the budget. However, Facilities Management maintains over 7.5 million square feet of county building infrastructure, and is the county department responsible for performing preventive, predictive and corrective maintenance activities in various locations spanning the county's 7,200 square miles. It is therefore proposed that, effective July 1, 2021, responsibilities for site and facility maintenance and administration of the budget be reassigned to Facilities Management, who will manage this important county asset going forward, and develop and propose plans and uses for the property that will add value to the residents of the County of Riverside. With approval, the fiscal year 21/22 Recommended Budget book will be updated to reflect movement of the
