BACKGROUND:

Summary

Riverside County Information Technology (RCIT) developed a Capital Asset/Project Plan that was approved and established by the Board of Supervisors on July 2, 2019 (Item 3.18). This plan is part of the department's overall management strategy to ensure the County's IT infrastructure and systems are properly maintained, managed, and kept up to date. This plan also identifies necessary upgrades to address future IT enterprise infrastructure needs and equipment. Capital Asset Reserve funding allows RCIT to set aside reserves in the current and in future budgets for capital asset purchases and replacements.

RCIT is requesting to use Capital Asset Reserves to fund the following projects: End of life Exadata Oracle equipment and to upgrade the existing backup system to the ExaGrid and Veeam Data Backup solution. In addition, the Human Capital Management (HCM) upgrade was anticipated to be completed by end of FY 19/20; however, it was not completed until November 2020. Lastly, RCIT is requesting to use unbudgeted revenue to fund the ServiceNow software increase and depreciation.

Impact on Residents and Businesses:

There are no negative impacts on residents or businesses in the County of Riverside.

Additional Financial Information:

In using Capital Asset Reserves funds, this budget adjustment does not increase rates and costs to the departments.
