- 1. Ratify and approve Amendment No. 2 to the Professional Services Agreement with Perris Valley Recovery Program, Inc. #CS-03725 for Domestic Violence Services to increase the contract amount by \$37,360 from \$358,482 to \$395,842;
- Ratify and approve Amendment No. 2 to the Professional Services Agreement with Cox Romain Psychology Services, LLC, CS-03727, for Domestic Violence Services, expanding coverage for the zones and increasing the contract amount by \$74,740 from \$107,825 to \$182,565;
- **3.** Authorize the Chair of the Board to sign both Amendments for Perris Valley Recovery Program (#CS-03725-02) and Cox Romain Psychology Services, LLC (#CS-03727-02) on behalf of the County.
- 4. Authorize the Purchasing Agent, in accordance with Ordinance No. 459 and based on availability of fiscal funding and as approved by County Counsel to: (a) sign amendments that exercise the options of the agreement including modifications of the statement of work that stay within the intent of the Agreement; and, (b) move the allocated funds among the vendors; and (c) sign amendments to the compensation provisions that do not exceed the sum total of 20% annually in additional compensation, up to \$61,688 for the remaining two years of the of the agreements.

#### BACKGROUND:

#### **Summary**

California Welfare and Institutions Code (WIC) 10601.2 requires Riverside County to develop and implement a System Improvement Plan (SIP) focuses on improving outcomes for children in the Child Welfare System. The focus of Riverside County's SIP is on reducing the incidence of child maltreatment and continued improvement of placement stability, reunification indicators and foster care re-entry outcomes. To meet these outcomes, while also meeting the unique needs of the population DPSS serves, domestic violence victims/survivors, perpetrators and their families receive individual and group counseling services to improve their coping and parenting skills.

Three vendors were awarded contracts through a formal Request for Proposal (RFP), DPARC-524, for Domestic Violence Services and approved by the Board of Supervisors on September 23, 2017, Agenda Item 3.16. The awarded vendors were: Olive Branch Counseling Center, in Zone 1 (Riverside Metro), Perris Valley Recovery Program, Inc., in Zone 2 (Mid County), and Cox Romain Psychological Services, LLC, in Zone 3 (Western and Southwest County).

During the annual review period for FY 20/21, the services offered by Olive Branch Counseling Center for Zone 1, became available for redistribution to the other awarded vendors. Amendment No. 2 seeks to redistribute the remaining services and budget of \$112,100 and increase the maximum reimbursable amount for Perris Valley Recovery Program, Inc., (CS-03725) by \$37,360, and Cox Romain Psychological Services, LLC, (CS-03727) by \$74,740, to ensure continuing services in Zone 1. Domestic violence counseling services and the increased need for counseling services throughout Riverside County due to the isolation created during the COVID-19 pandemic will therefore continue uninterrupted and as planned.

#### Impact on Residents and Businesses

Approval of these Amendments ensures that domestic violence counseling services, virtual or in-person, are continued in all Zones, and the increased need for services resulting from the COVID-19 pandemic are adequately funded.

## Additional Fiscal Information

Funding for these agreements was budgeted through the normal county budgeting process.

#### **Contract History and Price Reasonableness**

On February 9, 2017, Riverside County Purchasing Department issued a formal request for proposal (RFP) DPARC-524 for Domestic Violence Services. On September 26, 2017, Agenda Item 3.16, the Board of Supervisors approved and executed three contracts. On July 10, 2019, Amendment No. 1 for all three contracts was executed by the Purchasing Agent. In June of FY19/20, the contract with Olive Branch Counseling Center was not renewed for FY 20/21 and they were unable to provide services for Zone 1. Needed domestic violence services provided by Olive Branch Counseling will shift to the other two awarded vendors while staying within the original Aggregate Maximum Reimbursement Amount. The approval of this amendment will ensure services continue without interruption in Zone 1.

Zones are defined in the Geographical Zone List, attached hereto as Exhibit D, and incorporated herein by this reference."

Each party of this Agreement agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act (("CUETA") Cal. Civ. Code §§ 1633.1 to 1633.17), for executing this Agreement. The parties further agree that the- electronic signature(s) included herein are intended to authenticate this writing and to have the same force and effect as manual signatures. Electronic signature means an electronic record and executed or adopted by a person with the intent to sign the electronic record pursuant to the CUETA as amended from time to time. Digital signature means an electronic identifier, created by computer, intended by the party using it to have the same force and effect as the use of a manual signature, and shall be reasonably relied upon by the parties. For purposes of this section, a digital signature is a type of "electronic signature" as defined in subdivision (i) of Section 1633.2 of the Civil Code.
- 9. Miscellaneous: All other terms and conditions of the Agreement not modified herein shall remain unchanged and in full force and effect.
- 10. Effective Date: This Amendment No. 2 shall become effective July 1, 2020.
