Shirley was born February 12, 1935 in Girard, Ohio to Albert and Marie (Bauman) Smerber. Growing up on the family dairy farm in Ohio, Shirley developed a love of animals and music, and had a knack for growing flowers and fruits and vegetables. These interests continued when the family moved across the country to purchase land in Corona, California, where they started a small ranch in the El Cerrito area.

Shirley attended St Francis De Sales High School in Riverside, becoming a top-notch student and engaging in school activities. She was the editor of the school newspaper and the 1953 prom queen. After graduating, she worked briefly for Riverside County in the records department.

Shirley met the love of her life, Timothy Bernardy, in 1955, and they married in April of 1957. They had six children, 25 grandchildren and 21 great-grandchildren. Shirley was a selfless, wonderful matriarch of the family, who dearly loved and cherished her children and grandchildren. Shirley and Tim loved their travels throughout the U.S. in their 5th wheel trailer several years ago while still in good health. Shirley continued her love of music and she could be seen and heard humming, singing and dancing until her last few days.

Shirley and Tim were lifelong, devoted Catholics and were committed to the promotion of the Traditional Latin Mass in the Riverside area, first at St. Francis Church and later at Guasti in Rancho Cucamonga. Shirley was an enthusiastic choir member and organist at these churches. Later in life, they were also supportive, active parishioners at Corpus Christi Church in Corona California.

On motion of Supervisor Washington, seconded by Supervisor Perez, and duly carried, IT WAS ORDERED that the meeting of Tuesday, June 8, 2021, be adjourned in memory of Don Galleano, winery owner and Western Municipal Water District board member, passed away June 2, 2021, at the age of 69.

Don Galleano served on the Western Municipal Water District's board of directors since 2004, representing Eastvale, Jurupa Valley and Norco. He was truly a water icon in California, treasured board member, and pillar of the community, who was known for his historic relationships with the agricultural community. In addition to the water district board, he sat on the Jurupa Community Services District board. He served on the National Orange Show foundation board and the Los Angeles County Fair Association board. Galleano was also a past president of the Western Riverside County Businessman's Association and the Jurupa Chamber of Commerce.

Don Galleano was president of Galleano Winery in the Mira Loma area of Jurupa Valley. His family founded the winery in 1927. As fitting for a winery run by a long-time water board member, the winery does not use irrigation, but practices dry farming instead, which relies on moisture retaining soil.

Galleano never wanted credit for the kind things he did. He helped many more people privately, beyond his public acts of service, serving on local government boards and civic organizations. He had a tough guy image, but he really had a kind heart. Although Galleano was a wealthy man, he was humble. He didn't live a pretentious life, "things" weren't important to him.

Galleano left an incredible legacy for his children and grandchildren, not to mention the many members of the public he helped during four decades of public service in Riverside County. He came from humble beginnings, but used his wit and wisdom, along with hard work, to build a world -class winery. Beyond his work as an elected official, Don Galleano will be remembered for his outsized personality and love of the finer things in life, close family, good food, good cigars, and of course, good wine.
