

BACKGROUND: Community Improvement Designation Funds will be allocated to six (6) 2021 High School Graduates and one (1) 2020 High School Graduate, who served on the Fifth District Youth Advisory Council and are recipients of a Fifth District Scholarship.

1. This scholarship award is designed to recognize Fifth District Youth Advisory Council (YAC) members for their involvement and participation in the community and provide financial aid for their higher education pursuits.
 - a. All 12th grade Youth Advisory Council members were able to apply for this scholarship.

2. Eligibility requirements:
 - a. Graduating seniors must attend either community colleges, public colleges and universities, private universities, or eligible trade schools.
 - b. Total number of hours contributed to the council must be a minimum of 50% hours offered.
 - c. Scholarship is based on total number years student served as a member on the Youth Advisory Council.
 - a. < \$250 per year
 - d. Essay submitted that reflects their personal growth throughout their years and experience with the Youth Advisory Council.
