

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. March Air Field Museum-\$5,000: Funding will be used to support the programs and services at the museum that offer the opportunity to the community to experience and learn the history of military and civil aviation. In addition, funding will assist with the acquisition of the United States Air Force F-16 for the museum.
2. Beaumont Community Chamber of Commerce-\$2,000: Funding will be used to support their economic development towards programs, events and services that assist the community and small businesses.
3. Banning Chamber of Commerce-\$2,000: Funding will be used to assist with their annual economic development programs, services, small business/community outreach events, such as community food drives and assistance with their animal shelter.
4. Perris Valley Chamber of Commerce-\$2,000: Funding will be used towards their annual economic development programs, services and outreach events for the community and small businesses.
