BACKGROUND:

Summary

Gartner, Inc. is a leading IT research and advisory company that provides access to technology research across a variety of IT disciplines that help organizations keep up with technology and build the organizations of tomorrow. Gartner has provided RCIT and other County departments with indispensable business insights, advice, and tools that have been leveraged to achieve their mission-critical priorities. In fiscal year 20/21, RCIT and ACR utilized Gartner's core research services for independent analysis on new technology and technology directions, such as Data Backup, Hyper-Converged Infrastructure, Web Content Management Solutions, and other emerging technologies.

Gartner's assistance in these areas has benefitted both RCIT and ACR with the development of technology strategies, standards, and guidelines. In utilizing Gartner insights and services, the County can make informed decisions that are more cost effective, provide the greatest efficiencies, and provide solutions with the most value in a market where technology continues to be volatile. One example of this assistance was RCIT working with Gartner to vet our data backup solution from a technical perspective and provide a comparison of other similar technologies. This renewal will be handled directly with Gartner, saving a 2.5% administrative fee previously paid to the County of Ventura who administered the prior contract.
