

BACKGROUND:

Summary

As a requirement of the Federal Qualified Health Center (FQHC) designation from the U. S. Department Health and Human Services, the County must have a governing board for the RUHS Community Health Centers. The Community Health Center Board (CHCB) was established by County Ordinance 751 in 1996. The CHCB presently has nine (9) to twenty-five (25) positions of which a majority must be users of services at the Community Health Centers. While the members as a whole must also be broadly representative of the characteristics of the population served by the FQHCs, certain positions are reserved for representatives of the County departments that work most directly with the CHCs to ensure integration of effort on behalf of the CHCs.

The individuals listed below applied to, had been reviewed by and are recommended by the CHCB Board to this Board for membership on the CHCB:

Patient Representative – Cecilia Urrea

Ms. Urrea is currently a resource parent in her local school district. She has served on multiple advisory boards in Los Angeles County. She possesses over ten years of experience in the child development field. Ms. Urrea is also a patient of the RUHS Community Health Centers. As a patient, Ms. Urrea will be able to bring another perspective to the Board.


Impact on Residents and Businesses
