Sustained Moral Persuasion

Temecula City Council is this Tuesday morning, July 20th, 9 AM

Most of the Temecula City Council except for Jessica Alexander still thinks we need a REDI (Race Equity Diversity Inclusion) commission, even though every speaker, black and white, at a city council meeting last night (July 13th, 2021), said it was not needed. Not one speaker from the public spoke in favor of the REDI commission.

This acronym (REDI) means that Temecula has perceived systemic racism, inequity, similarities, or omissions that need to be pointed out by the commission and when any perceived racism, inequity, similarity, or omission is found, the commission will report that to the Council.
