Richard was born on December 22, 1946 in Hollywood, California. Six years later his brother Greg was born. The boys were raised in Canoga Park, and they had a happy childhood. Rick was in Little League baseball, Pop Warner football and continued to play football through high school. The family was active in the catholic church, the boys attended catholic school and Rick was an altar boy.

Rick joined the United States Marine Corps, after graduating from high school, attending Pierce College for two years, and working at Litton Enterprises. He was in combat for thirteen months in Vietnam, Khe Sahn and other areas in Vietnam. He enlisted in 1965 and was discharged in 1969. On Friday, the 13th of June 1969, he met the love of his life, Linda, on a blind date in Hermosa Beach, arranged by a mutual friend. They married on April 24, 1970 and shared fifty- one years together raising two children, Brigette and Brian.

Rick and Linda were active life members of the VFW (Post 10267), The American Legion (Post 500) and Vietnam Veterans of America (Chapter 47). Rick spent twenty years as a structural ironworker, Local 433 and after retiring worked as head custodian for Jurupa Unified School District until retirement. Rick and Linda became "Papa" and "Grammy" to four grandchildren, Brigette's two daughters, Summer and Marisa Staley and Brian's two sons, Brody and Kaleb Sapien.

On motion of Supervisor Spiegel, seconded by Supervisor Washington, and duly carried, IT WAS ORDERED that the meeting of Tuesday, July 20, 2021, be adjourned in memory of Clarence "Kit" Kirchoff, who passed away on June 18, 2021.

Kit was born in Milwaukee, Wisconsin on August 15, 1930 to Clarence and Mildred Kirchoff. He attended St. Michael's Catholic School, Peckham Jr. High, and Washington High. Kit enlisted in the Air Force in 1947, completing Basic Training at Lackland. After tours in South Ruislip, England, March AFB in California, Galena in Alaska, Ellsworth in South Dakota, and Kadena in Okinawa, Japan, he returned to March AFB for retirement as a Chief Master Sergeant (Security Police Superintendent) in 1969. Throughout his long military career, he was instrumental in rewriting the Air Force Security Manual and in creating new security policies and procedures for the newly established Aircraft Alert Area. While at Kadena he completed a BA from University of Maryland in Tokyo.

After retirement from the Air Force, Kit began working as a Deputy Probation officer for the Riverside County Probation Department. He started as an Adult Court Investigator, he advanced to Supervisor of the Family Support Unit, Assistant Director of Administrative Services, Assistant Director of Riverside Juvenile Hall, Director of Administrative Services, Director of Riverside Juvenile Hall, and Chief Deputy of all Field Service Divisions. He retired in 1995 as Assistant Chief Probation Officer. During his Probation Officer career, he found time to complete an MA in Correctional Counseling and an MA in Marriage, Family and Child Counseling. He also pursued postgraduate work toward his Doctorate in Human Behavior, at United States International University. Kit was a Eucharistic Minister at Our Lady of Perpetual Help Catholic Church, and a Life Member and Past Grand Knight of the Knights of Columbus Council 4793.

Margaret was the sixth generation of her family to be born in California. Margaret's great-grandparents, Manual and Delores Garduna Arnaiz, homesteaded in Kenworthy Valley in the 1800's. Her third great-grandfather, Jose Maximo Simon Valenzuela, was born at the San Diego Mission in 1791. Margaret loved being a cattle rancher's daughter, and she was happy to spend as much time as possible horseback riding, roping and branding the cattle. Nothing pleased Margaret more that to hear her Dad say, "you are a better hand than most men!"

Margaret joined local World War II efforts as a radio mechanic at Norton Air Force Base in San Bernardino, and it was there that she met her future husband, Adrian Jaenke. After their marriage, Adrian and Margaret went on to have seven children. The children kept Margaret very busy, as she taught them how to ride horses, sew, cook and play musical instruments. Along with being a mother and a full-time homemaker, she was a 4-H club leader and a PTA member.

After raising her children, Margaret focused on earning her Master of Education from Azusa Pacific University, and she dedicated herself to teaching at Hamilton School until her retirement in 1995. After retirement, Margaret kept busy as the founder of the Hamilton Museum & Ranch Foundation, a museum which shares the history of Anza and the local mountain area. She wrote three books about the local history: "In the Olden Day Revisited," "Looking Back, Anza and Garner Valley" and "Images of America, Around Anza Valley." In 1952 Richard and Patsy bought a trailer and followed a couple to California. They both got jobs at Douglas Aircraft. They used their trailer as a down payment on a house in Anaheim, near Knott's Berry Farm. Patsy left Douglas Aircraft to work at Farmers Insurance in Santa Ana, and later worked as a secretary for Hughes Aircraft in Fullerton. They retired again, in 1983 and moved to Cherry Valley.

Patsy and Dick planted and ran the Rocking "R" Peach Orchard in Cherry Valley for about seventeen years. They helped their son establish Creative Touch Ceramic shop, where Patsy taught doll-making classes. Patsy was very creative, she liked to sew, crochet, knit, make ceramic ware, hand-crafted porcelain character dolls and their clothes, oil painting and she also made greeting cards.
