**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. My City Youth Center- \$5,000 the funding will be used for the Community Food Program that provides food supplies for 200 families per week in the Hemet area.
2. California VFW Motorcycle Club- \$2,500 the funding will be utilized for food boxes for veterans, active military families and seniors who live in the Third District for a six-month period.
3. Riverside County Office of Education Foundation- \$2,500 the funding will be used for student scholarship program. The scholarships help high school students that are financially challenged and at-risk to pursue their college education.
4. First Tee Inland Empire- \$2,500 the funding will be utilized for the Inland Empire Jr. Golf Program. The funds will go towards purchasing equipment, supplies, and coaching fees.
5. Riverside University Health System Foundation- \$10,000 the funding will support the fundraising efforts of the Festival of Trees event. This event provides funds to purchase critical equipment and operate programs for pediatric patients of the hospital.
