SUBJECT: OFFICE ON AGING: Ratify and Approve Amendment No. 1 to Standard Agreement SP-2021-21-1 with the California Department of Aging (CDA) for Supplemental Nutrition Assistance Program Education (SNAP-Ed), to increase funds for the period of October 1, 2020 - September 30, 2021. All Districts; [Total cost: \$145,744 - 100% Federal]. 4/5th Vote Required

RECOMMENDED MOTION: That the Board of Supervisors:

- 1. Ratify and Approve Amendment No. 1 to Standard Agreement SP-2021-21-1 with the California Department of Aging (CDA), for Supplemental Nutrition Assistance Program Education (SNAP-Ed), to increase funds by \$26,124 for a total contract amount of \$145,744, for the period of October 1, 2020 September 30, 2021, and authorize the Chairman of the Board to sign the amendment on behalf of the County;
- Authorize the Purchasing Agent, in accordance with Ordinance 459, to sign Agreement Amendments, renewals and new agreements, as approved by County Counsel that do not substantially change the terms of the agreement to fulfill the requirements of the California Department of Aging Standard Agreement and use available funding through September 30, 2021;
- 3. Authorize the Riverside County Office on Aging Director, Deputy Director, to sign the Information Integrity and Security Statement, California Civil Rights Law Certification and Contractor Certification Clauses;
- 4. Approve and direct the Auditor-Controller to make the budget adjustment shown on Schedule A, attached; and
- 5. Direct the Clerk of the Board to return four (4) original amendments to the Riverside County Office on Aging for further processing.

BACKGROUND:

Summary

The Riverside County Office on Aging (RCOoA) currently has an agreement with the California Department of Aging (CDA) to administer funds allocated to the Supplemental Nutrition Assistance Program Education (SNAP-Ed), that includes an obesity prevention program and targets older eligible individuals. The goal of SNAP-Ed is to improve the likelihood of participants making healthy choices and choosing active lifestyles, while staying within a limited budget, consistent with the current Dietary Guidelines for Americans. RCOoA will provide evidence-based nutrition education and physical activity classes developed specifically for older adults. Using behaviorally-focused nutrition strategies, older adults will be educated and trained to make nutritious food choices, healthy lifestyle changes with their peers and learn about nutrition assistance programs, thereby reducing food insecurity. Older adults will participate in age-specific physical fitness training, focusing on maintaining strength and balance to reduce falls.

Amendment No. 1 to Standard Agreement SP-2021-21-1 increases the allocated amount by \$26,124. The agreement includes the most current requirements provided by CDA, but could be subject to modification based on the State's final legislative process.

The COVID-19 pandemic led to significant and unexpected delays in the agreement development and release process at the California Department of Aging, as well as in the review and approval process locally.

The term of this agreement is October 1, 2020 – September 30, 2021.

Contract History

Ordinance 459 allows for award of contracts with any federal, state, or local government agency without bidding due to the nature of collaboration and partnership of beneficial programs with government entities, as this Standard Agreement is between the California Department of Aging and Riverside County Office on Aging.

Standard Agreement No. SP-2021-21 was previously authorized by the Board of Supervisors on September 1, 2020, Item No. 3.11. This Amendment No. 1 to Standard Agreement No. SP-2021-21 increases the allocated amount by \$26,124 and maintains the original term of performance.

Impact on Residents and Businesses

Riverside County residents, 60 years of age or older, will be provided nutrition education and an obesity prevention program to encourage healthy choices and active lifestyles. Priority outreach will be provided to those in greatest social and economic need.

Additional Fiscal Information

Standard Agreement SP-2021-21 was approved by the Board of Supervisors on September 1, 2020, Item No. 3.17. This Amendment No. 1 to Standard Agreement SP-2021-21-1 increases the allocated amount by \$26,124; therefore, the attached budget adjustment is necessary to reflect the revenue under this agreement in the current fiscal year.
