BACKGROUND:

Summary

The Public Defender's Office requires access to online database subscription for legal research. Under the State Bar Act and Rules of Professional Conduct, the department is required to be competent in the representation of those accused of crime. Doing criminal defense work without the ability to research and find the law is prima facie incompetent representation (See Cal. Rules of Prof. Conduct, Rule 3-110 [member must be competent in (a) diligence, (2) learning, and (3) skill.]) Further, competent representation of those accused of crime is mandated by the State and Federal Constitutions. A failure to provide competent representation due to the inability to research and find the law could result in lawsuits for incompetency of counsel.

To conduct legal research, the Public Defender's Office use an on-line service, Westlaw Classic. Westlaw's platform is now called, Westlaw Edge, and provides the next generation of legal research, the most advanced citator service, the easiest way to see statutory changes, integrated litigation analytics, all powered by state-of-the-art artificial intelligence and built upon more than 100 years of editorial enhancement. Westlaw Edge is the only legal research solution that includes warning on implicitly overruled or abrogated cases even where the case does not cite to overruled authority. According to Ordinance 459.3, subscriptions to publications are exempt from the bid process.

As more justice reform laws are being implemented at the county Superior Court level, there will be more unsettled laws throughout the state being litigated at the appellate level and the circuit level. Having access to this platform will allow the Public Defender's Office to research in the cutting edge of new laws. The Department believes that the services of Westlaw Edge with Litigation Library will allow our attorneys and staff to provide the best possible defense for the County's indigent population.

Impact on Residents and Businesses

This agreement will provide the tools necessary for our attorneys and staff to provide the best possible defense for the County's indigent population.

Additional Fiscal Information

The 5-year cost for this online subscription service for legal research is: \$384,449. The cost per year is as follows:

FY 2021/2022: \$75,367 FY 2022/2023: \$76,121 FY 2023/2024: \$76,882 FY 2024/2025: \$77,651 FY 2025/2026: \$78,427

As an incentive to purchase their product Westlaw has agreed to a 1% annual increase if the county agree to a five-year contract term, with the option to "opt-out" at the end of each year.

Contract History and Price Reasonableness

This is a 5-year contract with a 1% increase each year. There is an "opt-out" option at the end of each renewing year. The Law Offices of the Public Defender has contracted with West Group since 2014 for their online legal research database subscription services. The products offered are exclusive in content, features and services.

Ordinance 459 allows for the award of agreements for subscriptions to publications without competitive bidding due to the prescribed service.
