On motion of Supervisor Washington, seconded by Supervisor Spiegel and duly carried, IT WAS ORDERED that the meeting of Tuesday, August 17, 2021, be adjourned in memory of Lois Carson, who passed away July 14, 2021, at the age of 90.

Lois Carson served for thirty years as the Executive Director of Community Action Partnership of Riverside County, CAP. She led CAP Riverside towards ending poverty on a local level and obtaining recognition at the state and federal level for her efforts. Carson promoted the vision of ending poverty through programs for utility assistance, conservation education, solar exploration and weatherization. During her tenure with CAP Riverside, she helped to establish the many thriving organizations and networks that serve low- income families today, including the Riverside County Consortium for Early Learning Services and the Coachella Valley Housing Coalition. She also implemented cool centers in 2001 in response to the extreme summer heat. Today Riverside County has more than 60 cool centers.

Carson led CAP Riverside to receive the 2005 Award for Excellence in Community Action. She was honored with the "Lyndon B. Johnson Human Service Award" in 2007 by the National Community Action Partnership organization. She was also the 2007 recipient of the State of California "Woman of the Year-Assembly District 62."

Carson's commitment went beyond Riverside County as she served as president of the California- Nevada Community Action Partnership Association (Cal-Neva), the state trade association and as vice president and president of the National Community Action Partnership, as national trade association.

Carson received a bachelor's degree in English from California State University, San Bernardino and a master's in English-Education form the University of California, Riverside. She was named a distinguished alumna by both institutions.

Lois Carson's memory and passionate spirit will live forever in the hearts of those who knew and loved her. She was referred to as a "pearl of community action" for inspiring employees and residents. She will be greatly missed but never forgotten.

She began and ran a successful business, selling organic plants and vegetables for fifteen years. She supplied several Riverside restaurants with her produce. In between growing seasons, Leslie worked for the Riverside Unified School District as a substitute teacher.

Leslie loved to travel and worked as a part-time travel agent. Her favorite form of travel was on cruise ships. Leslie was both a member and president of the Raincross Exchange Club of Riverside, for over eighteen years. She also worked with Para Niños and was a member of the Red Hat Society of Riverside.

He earned the Temecula Valley Chamber of Commerce's Lifetime Achievement Award in 2008. Parks and his wife Debbie enjoyed traveling to Palo Verde, Florida, Tahiti and Europe. His favorite hobby was golf. Whether he was dressed up as Santa Claus during the holidays or as Ernest Hemingway in a look-alike contest, Ron always brought cheer into peoples' lives and he lived life to the fullest.
