BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the August 31, 2021 Special District Mail Ballot Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On July 27, 2021, the Board of Supervisors approved the conduct of election services for the Special District Mail Ballot Election. Election costs fully reimbursable from the jurisdictions are approximately \$25,000.

The election was held on August 31, 2021 with ____% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast at the Special District Mail Ballot Election held August 31, 2021.

Impact on Residents and Businesses

Landowners in the Temescal Valley Water District had the opportunity to elect the Director for their respective district.

Additional Fiscal Information



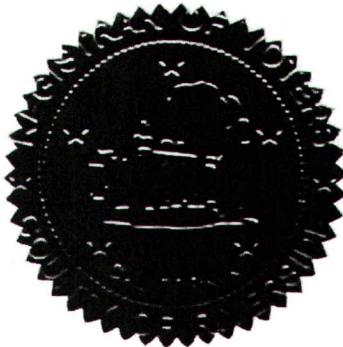
