Sally was born May 9, 1935, in Hollywood, California. She was the daughter of Julia Jones who was a Hollywood actress before movies had sound. Sally graduated from Hollywood High School and loved to sing and dance. She belonged to the Screen Children's Acting Guild and performed children's parts in several productions.

Sally and Dick married September 15, 1963 and remained married almost 58 years. She fulfilled her dream of being a Mom, adopting Mike, Dana and David. Sally was a mom to a lot of people. She was there with a shoulder to cry on, a listening ear, a hand to hold and reach out to, and a voice of reason when it was needed most.

Sally started serving the community at the young age of 6. For several years Sally and her friend went door to door with their wagons, collecting shoes and coats for the Los Angeles Union Mission. She volunteered at California Rehabilitation Center in the Hospitality Place for 15 years, and was on the board for 10 years, twice as President and as Secretary. She went through the chairs of Job's Daughters and became Honored Queen.

Sally was the superintendent of Sunday school for approximately 20 years, at the Corona United Methodist Church. She was President of United Methodist Women for 4 years. Sally directed a folk/rock musical group at her church for 9 years. Sally was a member of Corona Evening Kiwanis for 8 years, and President for 3 years. She worked with the Indian Maidens YMCA for 4 years, with her daughter Dana. She was a Big Sister to 4 girls in 17 years. She also ran the Orange County Chapter of Big Sisters, as a volunteer director for 10 years. She was a 4-H leader in Norco for 10 years. She ran the snack bar for Norco's Chet Nicholson relay for 20 years. Sally touched so many lives, those memories are a gift to all who knew her.

On motion of Supervisor Spiegel, seconded by Supervisor Perez and duly carried, IT WAS ORDERED that the meeting of Tuesday, September 28, 2021, be adjourned in memory of Ruth Jean Wilson, activist, family matriarch, and master gardener, passed away May 2, 2021, at the age of 98.

Ruth was born on January 31, 1923, in Cleveland Ohio. She was the first of three children born to parents Carl and Emily Darling. Ruth and her two sisters Betty Ann and Elaine grew up during the Great Depression. In 1942, Ruth married her childhood sweetheart, Fred Bratten. After the war, the couple attended college on the GI Bill, started their family in 1947, and eventually moved to Riverside California, where they raised their two daughters, Susan and Jill, and son, Jonathon.

Ruth was active in the PTA, Girl Scouts, Boy Scouts, Little League, and was an enthusiastic supporter of bake sales. She sewed most of her children's clothes and created elaborate birthday cakes featuring farms, fire trucks, and carousels. Ruth was driven by a promise she made to herself when she was twelve years old, she wanted to make a difference in the world.

Ruth helped form the Riverside chapter of the League of Women Voters in 1954. This association lasted the rest of her life, and it launched her lifelong commitment to environmental conservation, women's and civil rights, defense of the vulnerable, and dedication to community service. Ruth, along with two other League women, launched the "Save the Santa Ana River" movement in the early 1970's, an organization that eventually became the Tri-County Conservation League.

Ruth was an enthusiastic volunteer, a hard worker, and a strong leader in all that she chose to do. She served on the boards of organizations focused on the environment such as the Riverside County Parks Commission, Clean Air Now, the Santa Ana Regional Water Quality Board, the Prado Dam study, and the Southern California Watershed Fire Council. In addition to her decades of community service, in 1988 she ran for and won, a seat on the Rubidoux Community Services board, where she served six terms before retiring at the age of 95. In the last decades of her life, she was an active member of the AARP and traveled with that group all over the world, with her beloved domestic partner Jim.

Ruth truly gave herself to the world. She loaned money, tools, and advice to her tenants. She gave rides to women walking in the rain, painted over graffiti, watered public trees, and hauled new trash cans up Mt. Rubidoux when vandals destroyed the ones that were there. Her boundless optimism, generosity, and energy inspired others and blazed a trail for those who came after.
