Dear Supervisor Hewitt:

My name is Marshall Locke. I am a resident of the Nuevo-Lakeview community.

Last June, I submitted a public records request under the California Public Records Act to Riverside County, seeking information related to material of unknown origin and quality that was hauled and dumped onto the property known as Assessor's Parcel Number 309-020-005 in the Nuevo-Lakeview community.

The material in question was hauled by entities at the behest of and/or in coordination with 'KB Home', who reportedly plans to build nearly 300 residential homes on the property.

In response to my public records request, Riverside County produced soils reports for different material that had been subsequently hauled and dumped on the above property; however, it is clear the soils reports/documentation provided do not represent the material hauled and dumped on the property witnessed by numerous residents of the Nuevo-Lakeview community who commented about it on social media in April 2021.

Accordingly, it is reasonable to conclude Riverside County has – or should have – another soils report and/or documentation in its possession for the material of currently unknown origin and quality hauled and dumped on the property in question.

Under Government Code section 6253(c), Riverside County is required to verify whether there is such a soils report and/or related documentation in the County's possession, or not.

If Riverside County does not have these records related to the material in question in its possession, it must specify that – otherwise, as specified by Gov. Code Section 6253(a), Riverside County is required to "justify withholding by demonstrating that the records in question are exempt under express provisions of this section"

Supervisor Hewitt, I have contacted your office numerous times to arrange a brief meeting with you to resolve this matter; I am not able to explain why my multiple texts, emails, and phone calls to your office have gone unanswered.

Please know your office is in possession of my property that I would like to get back sooner rather than later.

While I do not speak for or represent the Santa Ana Regional Water Quality Control Board, I can tell you an inspector for them is very interested in and seeks information on the material of unknown origin and quality hauled and dumped on the property in question last April by entities on behalf of 'KB Home'.

Supervisor Hewitt: Too much time has passed since I submitted my public records request last June. Let us now at this late hour meet and resolve this matter.
