BACKGROUND:

Summary 3 1

On April 20, 2021 the Director or Transportation entered into an emergency contract with Riverside Construction Company, Inc., of Riverside, California for Emergency Road and Storm Drain Repair Work, Hostettler Road in the community of Alberhill. On May 18, 2021, Agenda Item 3.24, the Board of Supervisors received and filed this emergency contract.

In March 2021, a sinkhole and pavement failure due to water seeping out the of pavement was reported on Hostettler Road.

The Transportation Department and Elsinore Valley Municipal Water District performed an inspection of the facilities in the area to determine the cause of the seepage including a water analysis and other testing. Despite all the efforts conducted, the source of the water seepage was not determined. The Transportation Department determined that immediate evaluation and repair of the roadway was necessary to safeguard the public.

The original authorized amount of the contract was \$500,000. The total price of the contract came in at \$268,532 which is 46.3% less than the originally authorized amount. Due to the nature of the damage, the actual extent of the damage could not be fully determined at the time of contract execution and the quantity of repairs was less than originally anticipated.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on July 12, 2021.

Impact on Residents and Businesses

The roadway and culvert repairs restored safe access along Hostettler Road.




