He also performed for many years as part of the Cornbread Washtub Band, Mojave County, Phiddleharmonic, Banjomania, and Twopenny Opera. This meant going to countless bluegrass festivals, traveling in the motorhome, and camping with family and friends.

Gary's interest in cars was related to his livelihood. As a partner with the late George Crabtree, Gary was the CEO of Fiberglass Trends, and Auto Component Design which made parts for cars. His interest in vintage Packard Cars led him to the creation of the Disguise Battery Box, which allowed classic car owners to put a modern battery in a vintage car. Gary helped numerous car owners restore their cars to pristine condition and win awards.

Gary was a loyal friend to many, a loving spouse, father, and grandfather, who knew him for his kindness, intelligence, creativity, sense of humor and his generosity.

On motion of Supervisor Spiegel, seconded by Supervisor Hewitt and duly carried, IT WAS ORDERED that the meeting of Tuesday, November 9, 2021, be adjourned in memory of Charles (Charlie) D. Field, a retired Judge of the Superior Court of Riverside County, passed away peacefully on October 29, 2021. He was 85.

Charlie attended University of California, Riverside, as a member of the first four-year graduating class of 1958. He married his fellow classmate, Judy Anderson, and began serving in the National Guard. After receiving his law degree in 1963 from the University of California, Los Angeles, Charlie returned to Riverside to join the law firm of Best, Best, and Krieger, where he practiced for 27 years, primarily in labor and education law, and was also a managing partner. As a lawyer, he participated in many county and state legal organizations, and was on the boards of the Public Service Law Corporation of Riverside County and the Riverside County Law Library.

Governor Deukmejian appointed Charlie to the Superior Court in 1990, where he presided in the Juvenile and Civil Divisions, managed complex litigation, and served two years as Supervising Judge. After his retirement in 2004, he conducted private mediations and was elected to two terms as a Director of the Western Municipal Water District of Riverside County.

Charlie was passionate and tireless in supporting UCR and the civic life of Riverside. Among his many contributions: member of the Board of Regents of the University of California; membership on the UCR Alumni Association Board of Directors; founding chair of the UCR Foundation; president of the Citizens University Committee; a board member, including chair for 10 years, of the Riverside Arts Foundation; a15-year board member of The Press Enterprise Company; a board member of the Riverside County Philharmonic; and a board of trustee for the Mission Inn Foundation.

In his personal life, Charlie was known for his kindness, his wit, his recitations of Dr. Seuss, and his love and loyalty for family and friends. In his final years, he became a member of the First Congregational Church of Riverside. Charlie is survived by is devoted wife, Virginia Field, a retired UCR administrator, whom he married in 1984; his two sons, Robert (Tina) Field and John (Trish) Field; and his three stepchildren, Vicki Broach (Tim Kelley), Stephen (Sarah) Broach, and Cristi (Paul) Hendry. Charlie and Virginia share 15 grandchildren and six great-grandchildren.
