BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the May 2, 2017 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 21, 2017. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 24, 2017 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- Claim from Riverside County Code Enforcement Department based on a Notice of Pendency of Administrative Proceedings recorded July 16, 2014 as Instrument No. 2014-0264795.
- Claim from Michael C. Maddux, Esq., Agent for Michael E. Fehlow and Jeannine M. Fehlow based on Authorizations for Agent to Collect Excess Proceeds dated May 24, 2021 and June 07, 2021 and a Grant Deed that was recorded March 15, 2000 as Instrument No. 2000-094858.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Riverside County Code Enforcement Department be awarded excess proceeds in the amount of \$1,210.10, and Michael C. Maddux, Esq., Agent for Michael E. Fehlow and Jeannine M. Fehlow be awarded excess proceeds in the amount of \$61,805.27. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.
