### **Summary**

Government Code 7283.1 (d), part of Government Code Chapter 17.2 Standards for Participation in United States Immigration and Customs Enforcement (ICE) Programs, requires that the Board of Supervisors hold a public forum to provide information to the public about ICE's access to individuals and to receive and consider public comment. The Code also specifies that local law enforcement may provide the Board with data maintained regarding the number and demographic characteristics of individuals to whom the agency has provided ICE access, the date ICE access was provided, and whether the ICE access was provided through a hold, transfer, or notification request or through other means.

Comments:

Good afternoon. Thank you for holding this public forum. My name is Jessica Bansal and I am a senior staff attorney with the ACLU of Southern California. I attended this afternoon's meeting via phone, but was not given an opportunity to make my comment during the meeting.

I am here to join the ask of countless other community members: that the Board of Supervisors hold the Sheriff's Office accountable, ensure their policies and practices comply with the California TRUTH Act and Values Act, and take further steps to protect our communities, including by ending all ICE transfers.

We appreciate the Sheriff's report that there have been only two ICE transfers this year to date. We are concerned, however, that the Sheriff may be defining transfers narrowly, to include only in-custody transfers, where people are directly turned over to ICE by the Sheriff. We are concerned that the Sheriff also collaborates with ICE by informing ICE about individual's release dates and times so that ICE may arrest them in public areas of the jails immediately upon their release. We also consider this a transfer. We request that the Board of Supervisors ask the Sheriff to clarify whether its report included these types of transfers. We also request that the Board of Supervisors ask the Sheriff to provide the total number of transfer requests made by ICE this year to date.

The California TRUTH Act and Values Act were designed to protect Due Process for everyone in our community, regardless of immigration status. But these laws provide a bare minimum of protection, not the full relief our communities deserve. We therefore urge the Board of Supervisors to ensure that the Sheriff's Department completely abstain from immigration enforcement activity, including by following the lead of the Los Angeles Board of Supervisors and ending all ICE transfers. Anti-immigrant policies and practices have no place in Riverside County.
