On motion of Supervisor Spiegel, seconded by Supervisor Washington, and duly carried, IT WAS ORDERED that the meeting of Tuesday, November 17, 2021, be adjourned in memory of Douglas Coleman Austin, who passed away November 5, 2021 at the age of 74.

Douglas Coleman Austin was born in 1947, in Los Angeles, California, to Horace and Mary Austin. Doug was a 35-year resident of Idyllwild-Pine Cove who worked tirelessly to enrich the mountain communities.

After retiring from his career as vice president of Land 'O Lakes, Doug, dove into his passion for performing arts, founding the Old English Theatre company, and serving president of the Riverside Dickens Festival for 12 years, and a master greeter for Riverside County Renaissance Faire, for 10 years.

Doug founded the Doug and Mary Austin Charles Dickens Poster and Essay Contest, at Idyllwild School to promote children's literacy, and the SMARTS program, for which was twice bestowed upon him the Good Apple Award by Hemet Unified School District.

Doug's many philanthropic activities included the Mary Austin Memorial Award, given in conjunction with the Idyllwild Soroptimists, to women in the community in need. The Mary Austin Foundations has also funded in perpetuity nine grants through the Idyllwild Community Fund.

Doug contributed to children's literacy programs at Idyllwild Library. Some of the volunteer highlights he enjoyed most every year were overseeing the Green Room at the jazz festival, hosting Summer Concerts in the park (which he sponsored with his wife Pat), emceeing the annual Christmas Tree lighting, and participating in the Fourth of July parade.

Doug is survived by his loving wife, Pat Austin; his sons, Jim and Jeff; his brother, Jim; his stepsons, Paul and Israel, and five grandchildren.

Doug's memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed but never forgotten.
