**BACKGROUND:**

**Summary**

On November 4, 2020, the City of Canyon Lake approved a city resolution establishing a city municipal fire department to begin operations on January 1, 2022. Currently, the Riverside County Fire Department provides fire protection services. This cooperative agreement expires on January 1, 2022, at 0800. As part of the cooperative agreement, the City of Canyon Lake participated in the Riverside County Fire Department's acquisition and maintenance of the fire engine assigned to Canyon Lake Fire Station 60. The fire engine will remain with the fire station as part of the city's municipal fire department to serve the City of Canyon Lake. The City has requested an earlier transfer of the fire engine asset to prepare for the final transition. The fire engine will include the standard compliment of equipment for the City. Fire equipment costs are included in the Fire Department Cost Allocation plan in which the City participated in over the last sixteen years.

**Impact on Residents and Businesses**

The fire engine will be available for use by the City of Canyon Lake as part of their newly established municipal fire department.

**Additional Fiscal Information**

The fire engine has a useful life of 20 years and has not been fully depreciated. The fire engine's original cost was \$357,889 and was put into service in March 2007. Upon approval of the donation, the City of Canyon Lake will assume liability, transfer registration and insurance requirements on December 14, 2021.

**Contract History and Price Reasonableness**

The City of Canyon Lake has been contracted with Riverside County Fire Service since 1990 with a short break in service from July 2015 through September 2015. The cooperative agreement with the City of Canyon Lake was approved by the Board of Supervisors on June 29, 2021, Item #3.30. The cooperative agreement expires on January 1, 2022, at 0800.
