BACKGROUND:

Summary

The Coachella Valley Association of Governments (CVAG) was formed as a Joint Powers Authority (JPA) in November 1973 with the approval of the first Joint Powers Agreement (Agreement). Subsequently, and from time to time, the Agreement has been amended to admit new members into the JPA. For example, in April 2018, the Third Amendment to the JPA Agreement was executed to include the Agua Caliente Band of Cahuilla Indians and the Cabazon Band of Mission Indians as members. Most recently, in December 2019, the Torres Martinez Desert Cahuilla Indians re-joined CVAG through an addendum approved by each CVAG jurisdiction. Governments in the Coachella Valley have long benefited from relationships with the local tribal nations, whose reservations span across several local cities.

Earlier this year, CVAG was approached by the Chairman of the Twenty-Nine Palms Band of Mission Indians (Tribe) with a request for the Tribe to join the JPA. CVAG's legal counsel subsequently developed the attached Addendum No. 2 to the Agreement, with the sole purpose of adding the Tribe as a member. Addendum No. 2 has been reviewed and approved by CVAG's Executive Committee for final approval and execution by CVAG's member agencies, including the County.

Impact on Residents and Businesses

Membership in councils of governments such as CVAG allow member jurisdictions to collaborate in cooperative planning, coordination, and solutions to issues of mutual concern that cross jurisdictional lines, thereby benefitting all residents within a region.

Additional Fiscal Information

No fiscal impact is associated with the attached Addendum No. 2 to the Agreement.

ADDENDUM NO. 2 TO THIRD AMENDMENT AND RESTATEMENT OF THE JOINT POWERS AGREEMENT OF THE COACHELLA VALLEY ASSOCIATION OF GOVERNMENTS ADMITTING THE TWENTY-NINE PALMS BAND OF MISSION INDIANS TRIBE AS A MEMBER OF THE COACHELLA VALLEY ASSOCIATION OF GOVERNMENTS

This Addendum to the Third Amendment and Restatement of the Joint Powers Agreement of the Coachella Valley Association of Governments ("Addendum") is entered into as of the date of the last signature appended to this Addendum, by and between the Twenty-Nine Palms Tribe ("Admittee"), on the one hand, and the County of Riverside, City of Coachella, City of Indio, City of La Quinta, City if Indian Wells, City of Palm Desert, City of Rancho Mirage, City of Cathedral City, City of Palm Springs, City of Desert Hot Springs, City of Blythe, Agua Caliente Band of Cahuilla Indians, Cabazon Band of Mission Indians, and the Torres Martinez Desert Cahuilla Indians ("Current Parties"), on the other hand.

RECITALS

- A. Current Parties constitute the total membership of the Coachella Valley Association of Governments ("CVAG") and are parties to the Third Amendment and Restatement of the Joint Powers Agreement of the Coachella Valley Association of Governments ("Third Restatement").
- B. Admittee is a federally recognized tribe and public agency, as that term is defined in Government Code section 6500, and formerly a member of CVAG.
- C. Admittee desires to join CVAG as a member and Current Parties are willing to admit Admittee as a member under the terms and conditions set forth in this Addendum.
- D. Section 6.1 of the Third Restatement allows for the admission of additional public agencies to membership in CVAG subject to consent of two-thirds of the Current Parties and execution of an addendum to the Third Restatement signed by all Current Parties and Admittee.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and covenants herein contained, Current Parties and Admittee agree as follows:

Admission of Admittee

Admittee is hereby admitted as a member of CVAG, subject to all of the rights, obligations and responsibilities set forth in the Third Restatement. Execution of this
