



BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Culturas Music-Arts held their 10th Annual Synergy Music & Arts Festival on November 13, 2021. The festival is a free event to the public and brings talented artists, diverse music, car show, art displays and more. Funds raised will benefit their future center "Centro Cultural for Music & the Arts" serving at-risk youth.
2. The Girl Friend Factor (GFF) held their annual GoGirl! Luncheon on November 5, 2021. GFF is a local resource for women 25 years of age and better needing financial support to return to school and achieve their dreams. Over 180 women have received GoGirl! Grants. CID funds will support their mission.
3. The RUHS Foundation held their annual Festival of Trees event in November, benefiting the Pediatric Intensive Care Unit (PICU). The fundraiser helps purchase of desperately needed and often lifesaving equipment for the children's units at the Riverside University Health System Medical Center. CID funding will be used towards the purchase of crucial equipment.
