

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. **Restoration Agape - \$3,000** funding will be used to assist in providing much needed food to the Good Hope community. Food will be distributed to over 100 families in need once a month.
2. **Riverside County Office of Education Foundation - \$2,000** funding will be used to assist efforts to provide scholarships to disadvantaged high school students residing in the First District.
3. **Riverside County Philharmonic Association, Inc. - \$2,500** funding will be used to support the Philharmonic Association efforts along with the Riverside Arts Academy to offer a Summer Music Camp at the Cesar Chavez Community Center.
