BACKGROUND:

Summary

The Bulletproof Vest Partnership (BVP) Grant Act of 1998 (PL 105-181) established a 50-50 matching grant program to help states, local jurisdictions and tribal governments purchase lifesaving personal body armor for law enforcement personnel. The BVP Grant Program Reauthorization Act of 2015 includes a provision that states that the Bureau of Justice Assistance (BJA) may give preferential consideration to BVP recipients that provide armor vests to law enforcement officers that are uniquely fitted for such officers, including vests uniquely fitted to individual female law enforcement officers.

On March 9, 2021 (3.23), the Board of Supervisors approved the FY2020 grant award of \$239,682 to purchase bulletproof vests for law enforcement officers. On May 15, 2021, the Sheriff's Department submitted a grant application to purchase body armor for all law enforcement officers on behalf of the Sheriff's Department, Probation Department, and the District Attorney's Office. On October 8, 2021, BJA approved the County's application for \$198,997 via an e-mail notification.

BVP is a cost match grant program, and jurisdictions must provide a 50 percent cost match as stipulated by the Federal grant guidance. The BVP Program will reimburse the County up to 50 percent of the costs of each unit of eligible body armor purchased for law enforcement officers. The Sheriff's Department will share the \$198,997 allocation with the Probation and District Attorney's Office; however, each Department must cover their portion of the required 50 percent cost match in their budgets.

Impact on Residents and Businesses

There is no adverse effect on residents and businesses. These funds will be used to protect the lives of law enforcement officers by equipping first responders with armor vests.

Additional Fiscal Information

The Department's respective FY21/22 budgets will cover the mandatory 50 percent match for each qualifying bulletproof vest, while the BVP Program will reimburse the remaining 50 percent.
