BACKGROUND:

Summary

On July 21, 2015, Agenda Item 3.43 and 3.62 were approved by the Board of Supervisors, with strict limitations to dollar amounts for various agreement types with specific delegation of signature authority.

The approval of Resolution 2016-157 which authorized the Purchasing Agent to initialize and implement Public Contract Code Section 20131, subsection (c), for procurement not to exceed \$750,000 per vendor per twelve-month period was renewed and approved by the Board on July 12, 2016, Agenda Item 3-29, July 11, 2017, Agenda Item 3.42 and June 18, 2019, Agenda Item #3.20. On June 15, 2021 the Board adopted Resolution No. 2021-116 to authorize the Purchasing Agent to make procurements not to exceed \$750,0000 per vendor related to County hospital procurement procedures and activities until June 30, 2024.

Riverside University Health System-Medical Center's (RUHS-MC) primary objective was to reduce the time normally required to finalize an agreement. Typical agreements might provide equipment for patient service, initiate student internships, or generate new net revenue. In each case there is a sizable benefit to expediting the approval process. The secondary objective was to remove items that are repetitive or routine and thus, help declutter the Board's agenda.

RUHS-MC continues to report agreements and purchases approved under each specific delegated authority. Incorporated into this Board action is a report of all the Agreements and purchases approved during the first quarter of Fiscal Year 2021/2022.

Impact on Citizens and Businesses

Delegated authority allows for patient services to be delivered faster and more efficiently. Those agreements that increase revenue or accelerate payments improve the hospital's fiscal health.
